Notice is hereby given that Santaquin City Corporation (Owner) will accept bids for **Recreation Building Remodel (Project)** according to the Drawings and Specifications and in accordance with Santaquin City Standards and Specifications (http://santaquin.org/engineering.

The Project is described generally as follows: partial demolition and full remodel of an existing metal building structure with a footprint of approximately 4,000 sq. ft. A second-floor level will be constructed over a portion of the main level. The total square footage of the main and second floor will be approximately 5,558 sq. ft. The main level will have a large Recreation Room of approximately 2,200 sq. ft. and the remaining space will include: 5 Offices, a Conference Room, Restrooms and a Viewing Area. The second level will include 2 Exercise Rooms and a Storage Room. Exterior site improvements will be completed by others not associated with this Contract. Alternate bids will be received for the installation of ceramic tile in place of FRP on wall wainscots in the restrooms and at the drinking fountains.
