Notice is hereby given that Santaquin City Corporation (Owner) will accept bids for construction of the **400 West Drainage Improvements** Project according to the Drawings and Specifications and in accordance with Santaquin City Standards and Specifications (<http://santaquin.org/engineering>) and described in general as:

The Project consists of constructing **storm drain facilities, including; storm drain curb inlets, piping, a manhole and an infiltration gallery, curb, gutter and sidewalk, ADA ramps, areas of full roadway construction, an asphalt leveling course and a full asphalt overlay.** The work to be performed shall include final grade adjustments for existing manholes and water valve boxes. The work to be performed shall include all necessary materials, equipment, facilities, services, all necessary appurtenances, traffic and pedestrian control thereto needed for the completion of the construction project.

Separate sealed bids for the above described project will be received by **Santaquin City Office, 275 West Main Street, Santaquin, Utah 84655** until **2 p.m.** (local time) on **Wednesday, September 17, 2014**, and then, at said office, publicly opened and read aloud.
