Council Members in Attendance: Mayor Hunsaker, Nick Miller, Lynn Meacham, Chelsea Rowley, Betsy Montoya, and Keith Broadhead. Mayor Hunsaker called the meeting to order at 6:00 p.m.

NEW BUSINESS & ADOPTION OF ORDINANCES AND RESOLUTIONS

Canvass the 2019 Primary Election Results

Manager Reeves reported the official tallies for the primary election provided by the Utah County Elections Office. (See Attachment 'A').

Manager Reeves thanked the candidates for getting involved with the Community.

Motion: Council Member Montoya motioned to accept and approve the results of the primary election as reported by Utah County Elections Office to Canvas the vote. Council Member Rowley seconded. The vote was unanimous in the affirmative.

WORK MEETING - JOINT WORK MEETING WITH THE PLANNING COMMISSION

Discussion Regarding the Ekins Annexation Petition (Application)

Director Bond introduced Julie Smith who is representing the Ekin's Annexation Petition. Julie Smith presented information on the proposed annexation to the City Council and the Planning Commission (See Attachment 'B'). Ms. Smith noted that the proposed annexation would provide connectivity to the current Summit Ridge plan and Highway 6. She clarified that the property is currently zoned in the County under mining and critical environmental.

Ms. Smith stated that the total project size is 802 acres; 162 of those acres are currently annexed into Santaquin City. 721 acres have a recorded vesting mining right at this time. The proposal is to annex 639 acres from Utah County into Santaquin City. The applicant is requesting 6 units per acre. They are also proposing to create, and develop a park and then dedicate it to the City. The applicant is also proposing to mine the West side of the property that is next to Genola. Council Member Broadhead pointed out that there is a home adjacent to the proposed mining area.

Ms. Smith illustrated the following benefits annexing this property would bring to Santaquin: The applicant is willing to remove vested mining rights and move them to the west side. Providing paved access on Highway 6 to the Summit Ridge development. This development would bring additional rooftops, economic support, impact fees, and increase the tax base. She also noted the relocation of the current quarry that is currently by Summit Ridge to the west side.

Ms. Smith clarified that there would be both an asphalt and batch plant included in the mining operation on the west side. Regarding the time frame for the current mining operation, she explained they plan to continue mass grading the land for a year to prepare for development. Ms. Smith indicated that limestone, and regular rock are the materials that are mined from this land.

Ms. Smith provided clarification for the proposed densities; low density would be 1 to 3 units per acre. Medium density would be 3-8 units per acre (which is comparable to Summit Ridge) and the proposed High Density would be 8-14 units per acre. She noted that the high density would be happening in the future. They are envisioning a Grocery Store and Gas Station for the Commercial area.

Ms. Smith currently the farmers are on the East side of the property. The current operation is ¾ of a mile from the current farmers. When the mine is moved to the west it will be 3 miles away from current farming operations.

Council Member Broadhead asked what the total number of units would be. Ms. Smith answered that the developer is currently asking for roughly 4,000 units. She noted that they are proposing a Planned Community like Summit Ridge. Council Member Broadhead asked if there will be an HOA. Ms. Smith indicated that they are intending to have an HOA for the development. Commissioner Gunnell asked if they are anticipating to blast at the south east property that is currently being mined. Mayor Hunsaker indicated that the applicant has been blasting in the area they are currently mining. He also explained that Julie's employers have offered to show the Council a blast for reference. The Planning Commission and Council Members indicated interest in seeing a blast.

Mr. Bond communicated to Ms. Smith that further details and a development agreement draft are needed. He outlined the annexation process and explained that after the public protest period, October 1st is the anticipated date for a public hearing at the Council Meeting. After the public hearing the Council could make a decision on this annexation. Council Member Montoya indicated that she expects to see specific details for this development, rather than examples from other developments. She also asked to see specific details for this intended development and park. Mr. Bond explained that an annexation is a legislative action, it is up to the Council regarding how much information they will require. Director Bond noted that the developer can only be held to what the development agreement outlines, and asked that the development agreement is detailed. Ms. Smith explained that providing details for the homes is difficult, particularly if different developers come into the project. They can provide basic materials that will be used, etc. She indicated that she can provide more specific details for the subdivision entrance, and park. Commissioner Lance addressed density and noted that as a real estate agent, she sells larger lots more often than smaller lots. Council Member Montoya clarified that she would expect to see examples that would meet Santaquin City Standards versus Other Cities standards. Mayor Hunsaker stated that he would like to see that the CC&R's are stuck to.

Mr. Bond noted that the annexation area is 640 acres. He understands that the applicant has roughly 80 acres of property already in Santaquin City, and asked where the additional land is coming from. Ms. Smith explained that the property was recently purchased and is located in the North West most corner of the annexation property. Mr. Bond informed Ms. Smith that code currently requires 800 acres for a Planned Community zone. He also asked if the Council wants the mining area included in a Planned Community. Commissioner Lance pointed out that the mining zone that the Planning Commissioners are currently working on doesn't allow batch plants or asphalt plants. Ms. Smith indicated that they would like to include the mining area as part of the Planned Community as future development. Mr. Bond noted that local regulations can be enforced if a mining zone is imposed for the mining area. Ms. Smith asked if the Council would be willing to change the planned community acreage requirement. Council Member Miller stated that he can see a potential benefit of reducing the Planned Community acreage, rather than including this proposal in Summit Ridge. Council Member Broadhead indicated that he is ok with this proposal, and a batch and asphalt plant.

Council Member Rowley reported that Thad Rowley is in attendance concerning mining impacts to farms. Mr. Rowley explained that dust affects fruit trees and farms. He stated that when Valley Asphalt ran a batch plant, his farm was greatly affected and extensive damage was done to his trees. Mr. Rowley asked that enforcement be included in a mining zone in order to maintain it. Mayor Hunsaker explained that the Council is considering County versus City regulations in deciding whether to annex the property into Santaquin City. Mr. Rowley offered to provide information regarding dust damage to the Council.

ADJOURNMENT

Council Member Miller motioned to adjourn at 6:59 p.m. Council Member Meacham seconded.
