# MINUTES OF A JOINT WORK MEETING OF THE SANTAQUIN CITY COUNCIL AND SANTAQUIN SENIOR CITIZENS BOARD HELD IN THE COUNCIL CHAMBERS MAY 23, 2018

The meeting was called to order by Mayor Kirk Hunsaker at 7:00 pm. Council Members attending: Keith Broadhead, Lynn Mecham, Nick Miller, and Betsey Montoya.

Others present: City Manager Ben Reeves, Community Development Director Jason Bond, Recreation Director Amy Johnson, Senior Citizen Center Director Judy Robbins and her husband Val Robbins, Museum Director Annette Bott and members of the Senior Citizen Board, Museum Board, American Legion and interested members of the public.

#### INVOCATION/INSPIRATIONAL THOUGHT

#### PRESENTATION:

City Manager Benjamin Reeves gave a presentation regarding the current state of the city facilities along 100 South as well as the various options the city has been exploring to continue the operations of the Senior Citizen Center.

After the presentation, the group discussed the merits of each option. While the City Council initially determined that the use of the facility should end after the current year's services were completed (e.g. Summer of 2018), the Council ultimately determined that more time was needed to explore every option so that the seniors could continue their services and programs until a formal plan was agreed upon. The City Council determined to extend the use of the facility until the Summer of 2019.

The DUP Cabin Lease Contract was also discussed. The City Council determined that they had no issue if the DUP Cabin Lease Contract were to automatically renew for an additional ten (10) year period.



#### History:

- An initial report in 2005, authored by former council member Wes Morgan and co-signed by former city manager Stefan Chatwin, outlined concerns with the structural integrity of the city buildings along 100 South.
- In 2013, the Santaquin City Council began discussion regarding the deteriorating conditions of the structures. These concerns were outlined in the FY2013-14 budget documents as well as every year since.
- In 2015, a study of the structural analysis of the museum portion of the building was conducted. The cost for a structural retrofit of the museum alone was \$3.37M which did not address, electrical, plumbing, HVAC, ADA, nor the restoration of interior walls, ceilings & floors.





#### History:

- In January of 2017, the Santaquin City Council decided to propose the construction of a new senior citizens center and directed city staff to prepare to place this project on the ballot.
- From February 2017 through August 2017, the city staff, at the direction of the council, met with the seniors board, library board, museum board and recreation board to garner support and flesh-out the proposal for the ballot.
- In August of 2017, the Santaquin City Council formally passed a resolution to place the proposed project on the ballot.
- · A 50:50 matching grant was obtained to prepare the concept plan for the building



  - Four initial contacts made with Church Building Officials
  - Included a tour of Santaquin City
  - In process of interest levels and possible terms
  - Concept being reviewed by the Area Presidency








#### Conclusion
