PUBLIC FORUM, BID OPENINGS, AWARDS, AND APPOINTMENTS

Mr. Sakievich lives in Spanish Fork for running for County Commissioner Seat A. Broadhead asked what his thoughts were with regard to a county council. Mr. Sakievich reported Utah County is small with the roll to support the City and Towns who support their residents. The have the roll to coordinate the infrastructure. He asked if Mr. Sakievich had a problem with 3 people acting as the legislative and administrative bodies. After a brief discussion, Council Member Broadhead indicated he would attend his "town meeting" to ask questions.

Mr. Wride reported "a residential neighborhood is meant to be protected by the Ordinances that are already in place regarding noise, exhaust, nuisances, ect. There are many home businesses that have little impact on their neighborhood because they are regulated by the City. However, a large vehicle business can operate in and out of the neighborhood every day, perform maintenance, and other activities, simply because they have a business license somewhere else.

This type of business should have to comply with the Santaquin Ordinances that are already in place".

Mr. Crabb is building the Crabby's located at Highway 6 and SR198. He is questioning why he can't place a pole sign within 200 feet of an intersection. He voiced his concern since "a pole sign is marketing". He believes not being able to install the sign would affect his revenue. He is requesting the Ordinance be reviewed and he be allowed to install a pole sign. He was told the Planning Commission would take his request under consideration.

WORK MEETING

Discussion Regarding Summit Ridge Parkway Extension

It was reported the Summit Ridge residential property is being sold. Until the transaction is complete the negotiations on the second access is on hold. City Manager Reeves voiced his concern with note having the bonding process started. He requested direction with regard to beginning the bonding process. He was instructed to begin the bonding process, get a cost for a transportation study and keep the Council Members updated as needed.

Discussion Regarding Orchard Lane Commercial Development Area

City Manager Reeves reported Engineer Beagley is working with Ridley's Engineering Firm to "nail down" infrastructure needs. A discussion was held with regard to a time based incentive package. Also mentioned with that the same incentive does not have to be offered to everyone. Council Member Broadhead suggested letting the developers "make the first moved and go from there". Council Member Montoya feels the City should approach the developers with an incentive offer instead of waiting for them to come to us. It was suggested to dedicate some of the impact fees back to them. If was determined to begin the negotiations at \$300 hundred thousand and move up to \$500 hundred thousand. The offer will include a graduated scale with regard to the time frame associated with beginning construction. The "clock" will start on the day the offer is made.

Chamber Business of the Month

Ms. Walker introduced Mr. and Mrs. Ballamis, Lou's Barbershop, as the May 2018 Business of the Year. They are celebrating their 22nd year as a Payson business. Congratulations to Mr. and Mrs. Ballamis.

Discussion Regarding Home Occupation Business License Definitions

Legal Counsel Rich reviewed the current changes to the current code. He indicated the Ordinance is not ready to be adopted but would like some direction from the Council Members. An in depth discussion was held with the need to have a city business license, parking large vehicles off property, as well as doing maintenance on the vehicle. Council Member Broadhead asked if the proposed Ordinance will be defendable in court. Legal Counsel Rich asked for specifics as to what needed to be defended. Mayor Pro Tempore Miller voiced his frustration with those who willingly and knowingly snub the regulations of City. Legal Counsel Rich was asked to add the following to the proposed Ordinance; allowing parking on their property only (not on the roadway), no maintenance on the vehicles unless it is in compliance to the code and the business would be required to obtain a City Business License.

A 5- minute break was taken at 7:59 pm was taken.

At 8:03 pm the regular meeting resumed.

Discussion Regarding Vicious Animal Regulations

City Manager Reeves reviewed the history with regard to the adoption of the current Ordinance. After the history review, Legal Counsel Rich reviewed the proposed changes to the Ordinance.

After the review, he was asked to include requiring a chip placed when a dog is required to leave the City limits. The Ordinance will be "cleaned up" and ready for adoption in a future meeting.

Discussion Regarding the FY2018-19 Budget

City Manager Reeves indicated he is working on the future year budget. The tentative budget should be ready for review by next week.

There weren't any Petition or Communications to address this evening.

REPORTS OF OFFICERS, STAFF, BOARDS, AND COMMITTEES City Manager Reeves

It was determined a work session will be held during the May 16th during the Regular Council meeting.

City Manager Reeves reported the Mayor will be signing bond documents on Tuesday.

He indicated he would like to schedule a special meeting to plan development on Exit 242. He would like to bring the important players together to hold a discussion.

In closing, he reported the city is working with the School District for the construction of 500 West. He will be attending the Board Meeting on May 9th. He reported Nebo School District has property to the West of the current Santaquin Elementary School which the City may be interested in. Mike Robertson has voiced interest in trading property with the School District as well. Mayor Pro Tempore Miller voiced his support in purchasing the "West" property. City Manager Reeves was instructed continue negotiations with the School District.

Community Development Director Bond

Director Bond reported the next Planning Commission may be cancelled due to there may not being anything to discuss.

City Engineer Beagley

Engineer Beagley reported the Recreation project is behind by approximately a week. Due to the weather, the Contractor may not meet the May 15th substantial completion date. An additional discussion will be held if needed.

He reported the Pump Station Project will begin by the 1st of June.
