## Discussion and Possible Action Regarding Surveying Services and Community Engagement Software

City Manager Reeves reported as the City's Elected Leaders and City Staff have been evaluating the various alternatives as to where the Senior Citizen and Veterans program might continue their operation, two of the proposed alternatives involved the possibility of placing another bond initiative on the ballot (i.e. try again with a revised Senior Center Plan – or – place an initiative on the ballot for a new Recreation Center and then dedicate the old Public Works Building to the Senior's use). No one wants to proceed in a manner that is contrary to the will of the people and no one wants to expend effort toward another failed bond proposition (see attachment "A"). Mr. Winder reviewed the Qualtrics product. The Council Member asked questions with regard to product. Council Member Rowley voiced her concern with spending the amount of money on survey product instead of using the money to directly benefit the senior's. Council Member Broadhead suggested waiting until June 16th, after the Diamond Rio Concert. If the concert doesn't pay for itself, we will have to pay for it somehow. City Manager Reeves indicated if a ballot issue is being considered the more community involvement the better. Council Member Miller and Council Member Montoya voiced their support of the product.

### Discussion and Possible Action Regarding the Utilization of Utah County Parks Grant Proceeds

The Utah County Recreation Grant is a grant program where money is awarded each year to municipalities in Utah County based on population. A grant application must be submitted outlining the details of the project, its cost and how it will benefit the community. This is a reimbursable grant and there are no matching funds required.

This year's grant is in the amount of \$5,656.24. The funding has to be spent on development or construction of tourism, recreation, cultural and/or convention facilities. In the past, we have used the money for things like improvements on playgrounds and the arena as well as replacing fences at some of the ball fields, etc.

The grant opportunity has been discussed with Public Works Director Eva, Public Works Supervisor Callaway and Public Lead Kearl the possible projects. Following are 2 possible projects:

- Playground equipment at Centennial Park would like to replace the playground equipment that used to be in the gravel. It was recommended 2 or 3 new "rocking toys" like we have at Summit Ridge Park. Each piece of equipment is approximately \$2,000 to \$3,000.
- Ball field fencing every few years we need to replace sections of fencing at our ballparks. In the past, the cost was approximately \$7,000.

To meet the requirements of the application, during this meeting, the City Council will need to determine the project that will be applied. The application is due by May 4, 2018.

Council Member Broadhead was told placement of flagpoles at the arena as a possible project was discussed. Director Eva is gathering bids which he believes would be under \$1000.00. Council Member Rowley would like to use some of the money for the flagpole then the balance towards playground equipment.

After the discussion, Council Member Rowley moved to use the Utah County Parks Grant to install a flagpole at the arena and remainder of the funds be used for playground equipment. Council Member Miller seconded the motion. The vote was as follows:

Director Bond reported during the February 7<sup>th</sup> City Council Meeting, the Council discussed and gave direction to Staff regarding the Home Occupation Code. The Council also asked that a proposed amendment be created, a Public Hearing be held, and that a proposed amendment be reviewed by the Planning Commission. The purpose of the code amendment is to change the language to ensure that impacts of a home occupation can be properly mitigated by Santaquin City (see attachment "C"). Council Member Broadhead and Council Member Miller voiced their concern with changing the Ordinance because 2 neighbors can't "get along". City Manager Reeves reported the issue driving the Ordinance change is due to the issue of the business owner choosing to get a business license in Provo instead of getting one in Santaquin because of the different regulations. Legal Counsel Rich asked if the Council Members wanted the definition narrowed down or do they have the concept issue.

Mrs. Durrant indicated their office is in Provo and some of their equipment is stored in Provo as well as landscaping rocks being stored at a 3<sup>rd</sup> location.

Council Member Montoya voiced her concern that a Business License, for a business run out of their home, should have a City license. Council Member Miller asked if the Durrant's have a business in Provo why are they not working on the equipment at that location.

Mayor Hunsaker indicated that the neighbors need to be kinder to each other and be respectful of each other.

#### Executive Summary/Research:

As the city's elected leaders and city staff have been evaluating the various alternatives as to where the Senior Citizen and Veterans programs might continue their operation, two of the proposed alternatives involved the possibility of placing another bond initiative on the ballot (i.e. Try again with a revised senior center plan – or – Place an initiative on the ballot for a new recreation center and then dedicate the old public works building to the senior's use). Of course, no one wants to proceed in a manner that is contrary to the will of the people and no one wants to expend effort toward another failed bond proposition.

The way to better insure that our efforts are in harmony with the will of the people, and to lower the risk of a possible bond failure, the city staff is recommending that we enhance our community engagement capabilities and feedback efforts through a series of community wide surveys on this issue. Additionally, there may be times in the city's future when the city may want to obtain the pulse of the people on a variety of other relevant subjects. Having an ability to survey in a logical and scientific manner will insure that the council receives the best information possible to assist you in your decision making. It will also insure that the loud voice of a small minority does not overshadow the will of the silent majority who may or may not agree with the chatter of the day. Enhanced two-way communication will allow us to be proactively in determining to the needs and desires of the people without unduly being placed in a reactionary position whereupon we are responding to a few loud voices on social media.

During my review of survey service providers, I interviewed two companies with differing methodologies. The first is a company called Qualtrics and the other is a company called Cicero (otherwise known as Dan Jones). Qualtrics is a surveying tool and database collection service which evolves and grows over time with each additional survey. It is very customizable and can be used as often as desired. Qualtrics specializes in serving municipalities, counties, and school districts, etc. Alternatively, Cicero is structured under a more historic model of blanketing a population with phone, paper, and electronic surveys on a specific subject (e.g. political campaigns, product

research, etc.) Cicero provides a very accurate snapshot under very specific criteria. In short, I would say that Cicero is more issue centric and Qualtrics is designed to be more conversational over the long-term. Both have their advantages and disadvantages and both overlap each other with their service offering. However, both companies approach their ability to meet their client's needs from two entirely different approaches.

#### Recommendation:

After considering our city's needs regarding this specific issue, as well as the benefits we might derive on a variety of other issues, it is my opinion that the offerings provided by Qualtrics better matches our community's long-term desires. I had the opportunity to tour their rapidly growing Provo based corporate headquarters and see their employees in action. I had the opportunity to interview many of my peers (customers) from neighboring cities who utilize their offerings in an extensive manner (e.g. Provo, South Ogden, etc.). Furthermore, I have evaluated the cost structures of both companies and found that Qualtrics, who's pricing is under a Utah State Procurement Bid contract, is more advantageous to the financial constraints of our community. As such, my recommendation is that the City of Santaquin utilize the services of Qualtrics.

However, to insure that my recommendation is in harmony with the council's desires, I have asked Chase Winder from Qualtrics to present his proposal to you in person. This will give you the opportunity to review his presentation first-hand and receive direct and unfiltered answers to your questions.

#### Financial Impact:

The effort to seek the public's approval of the failed Community Cultural Center was funded under a 50/50 grant provided by the Mountainland Association of Governments (MAG) with a total budget of \$40,000 (e.g. \$20K City, \$20K MAG). The total funds expended for this effort were \$18,394.99, of which \$17,500 was paid to CSRA Architects for their services, renderings and mailers, and the remainder was used by the city staff for our Voter Information mailer.

City's Portion of Budget:

\$20,000.00

City's Portion of Expenditures:

\$9,199.50 (50% of \$18,394.99)

Remaining Funds Available:

\$10,802.50

Arguably, these funds were allocated for the determination and fulfillment of the facility needs of our Seniors and Veterans. I would recommend that we utilize the remaining funds available for a one-year, first level tier (\$10K), service contract with Qualtrics so that we might continue our initial efforts of determining and fulfilling the facility needs of our Seniors and Veterans.

<u>Recommended Motion:</u> Motion to approve a 12-month, tier-1, service contract with Qualtrics in an amount not-to-exceed \$10,000.00.

#### Santaquin City - Recreation Center Bond Proposal Research

#### **PROJECT BACKGROUND**

Benjamin Reeves contacted Cicero Group/Dan Jones & Associates to help draft and conduct research on behalf of Santaquin to measure residents' desires regarding a potential recreation center or facility in the city. In 2017 the city put a bond on the ballot for a new senior center, to replace the outdated senior center, but it did not pass. As a result, city leaders want to determine what type of recreation center will be the most widely accepted. City officials also want to measure what voter appetite is for a bond to pay for the construction and maintenance of the recreation center.

#### **RESEARCH OBJECTIVES**

In order to best inform and city leaders about what type of recreation options citizens desire, as well as if voters would vote to pay for it, Cicero Group recommends:

- 1. Identify the type of recreation center desired by Santaquin residents
- 2. Understand what type of amenities and/or options residents want in the recreation center and what amenities are more important than others
- 3. Discover level of support for such a recreation center in a bond election
- 4. Identify what type of messaging most resonates to prompt residents to support the bond

#### QUANTITATIVE RESEARCH

#### RECOMMENDED METHODOLOGY

Cicero recommends two separate surveys.

The first survey will identify the type of recreation center citizens' desire and would consider paying for, as well as what amenities they want in the rec center by utilizing a conjoint survey that is administered online. Such a survey presents random options to residents in a variety of combinations to zero in on true preference of the respondent. This will help determine exactly what residents want in a recreation center. Cicero recommends utilizing the email addresses of residents on hand, as well as postcard distribution to households in the city inviting citizens the complete the survey. Each postcard and email invite will have a unique password, ensuring that residents are not able to take the survey more than one time. Cicero recommends surveying 600 or 800 residents in order to obtain an acceptable margin of error and confidence in the results.

The second survey will present the final recreation center proposal to be included on the ballot, as determined by the city of Santaquin, and measure residents' willingness to vote for the bond. The survey will also measure what types of messaging and methods of communication will reach the most residents. Cicero again recommends using emails and postcards to meet residents, and if necessary, Cicero will utilize its call center to obtain the desired sample size. Cicero recommends



surveying 600 or 800 residents in order to obtain an acceptable margin of error and confidence in the results.

Due to additional information and analyses requested by USDA-NRCS to be include within the Supplemental Plan Environmental Assessment (EA), Horrocks Engineering is requesting a Change Order for the added project scope and associated fees for that change in scope.

Horrocks Engineering originally anticipated that the additional work requested by NRCS would have been in a future Final Design phase. However, USDA-NRCS has asked for this additional work to be included in the Supplemental Plan EA.

For your information, the current Supplemental Plan EA contract between the City & Horrocks Engineering is for an amount not to exceed \$194,700.80. The amount of the requested Change Order is \$56,141.00.

In late 2017, the City received an award from USDA-NRCS in the amount of \$370,000.00 for the Supplemental Plan EA work. Therefore, there is sufficient funding from the USDA-NRCS award to fully cover 100% of the project, including the requested change order. For this portion of the project (Supplemental Plan EA) the City is not responsible for any of the project costs. The USDA-NRCS funding covers all of this work within the award of \$370,000.00 to the City.

I have reviewed the requested Change Order with the staff at USDA-NRCS. They, as well as City staff, are comfortable with the Change Order amount to cover the requested additional work.

**Recommended Motion:** Motion to approve the change order with Horrocks Engineering for the additional work requested by, and paid for by, NRCS in an amount not to exceed \$56,141.00.

Re: Amendment Related to the Business License Requirement for Home Occupations

At the February 7<sup>th</sup> City Council meeting, the Council discussed and gave direction to staff regarding the Home Occupation code. The Council also asked that a proposed amendment be created, a public hearing be held, and that a proposed amendment be reviewed by the Planning Commission. The purpose of the code amendment is to change the language to ensure that impacts of a home occupation can be properly mitigated by Santaquin City.

A regulation has been drafted which requires any property that involves business related activities, to obtain a Santaquin City business license and therefore be subject to the regulations of the Home Occupation ordinance (Title 10 Chapter 12). Essentially, if it looks like a business, sounds like a business, smells like a business, etc. then it should be regulated like a business.

Concerns have been made about the impact an amendment would have to other residents in Santaquin City that also use large vehicles for commuting purposes or for their own business in the City and which do not create a problem for their neighbors. As a result, there are some proposed changes in the language that would lessen the regulations and allow for those home occupations that rely upon the use of a vehicle described as a "box truck". However, the primary purpose of this amendment is to ensure that all business related activities in a residential neighborhood are properly mitigated through Santaquin City codes.

The Planning Commission's recommendation is as follows:

**Motion:** Commissioner Adcock motioned to send a positive recommendation to the City Council to approve the proposed amendment to the Home Occupation ordinance. Commissioner Tolman seconded.

Roll Call: Wood Aye, Adcock Aye, Tolman, Aye, Lance Aye. The motion passed 4 to 0.

The proposed amendment is attached.

**Staff Recommendation:** Approve the proposed amendment.

Amendment Related to the Parking Area Access Requirement

Bruce Fallon is the Principal for WPA Architecture and is working with the owners of the new Central Valley Medical Center (CVMC) Santaquin Clinic that is currently under construction on Main Street. Mr. Fallon recently submitted a proposal to have Paragraph 10-14-5E of the Santaquin City Code amended.

The site plan for the CVMC Santaquin Clinic has been approved and is compliant with the current Santaquin City Code. However, the owners of the property have expressed a desire to only construct one access instead of two (see attached letter from Bruce Fallon). The current code requires that "any development which will have a parking area which is designed to accommodate more than twenty (20) vehicles shall provide a secondary access for ingress to and egress from the site." Staff has not been able to find any reasoning behind the current requirement.

The approved CVMC Santaquin Clinic site plan reflects a parking lot which is required to have more than 20 spaces and was approved with two accesses (see attached site plan). The proposed amendment essentially proposes to change the requirement from being based on a number of parking spaces to being based on the Average Daily Trips (ADT) that the use of the property would generate. The proposed amendment is as follows:

"Any development with a single point of access (ingress and egress) shall have a maximum ADT (Average Daily Trips) of two hundred fifty (250) trips. Any development that exceeds an ADT of two hundred fifty (250) shall provide secondary access for ingress to and egress from the site."

Daily trips are part of a formula that Santaquin City currently uses to calculate the transportation impact fee. The daily trips are determined by using data from the Institute of Transportation Engineers (ITE). Since the City has the capability of determining ADT, the proposed ordinance would not require that the applicant have a traffic engineer determine the ADT.

The proposed ordinance amendment suggests that the maximum amount of trips allowed before a secondary access would be required is 250 trips. According to the ITE data that the City uses and based on square footage, the CVMC Santaquin Clinic would generate 160 trips.

The Planning Commission's recommendation is as follows:

**Motion:** Commissioner Lance motioned to send a positive recommendation to the City Council to approve the proposed verbiage for Parking Lot Access Requirments. Commissioner Tolman seconded.

Roll Call: Wood Aye, Adcock Aye, Tolman, Aye, Lance Aye. The motion passed 4 to 0.

The proposed amendment is attached.

Staff Recommendation: Consider the proposed amendment.

**Recommended motion:** "Motion to approve Ordinance No. 04-02-2018 that would change the parking area access requirement from being based on a number of parking spaces to being based on the Average Daily Trips (ADT) that the use of the property would generate."

Mr. Bond,

We are writing to request a modification to the Santaquin City Municipal Code.

As you are aware, currently, Section 10-14-5, paragraph E, reads: "Any development which will have a parking area which is designed to accommodate more than twenty (20) vehicles shall provide a secondary access for ingress to and egress from the site."

It is our request for the change to this section to read as follows:

"Any development with a single point of access (ingress and egress) shall have a maximum ADT (Average Daily Trips) of two hundred fifty (250) trips. Any development that exceeds an ADT of two hundred fifty (250) shall provide a secondary access for ingress to and egress from the site."

This request is based upon the following research:

First, the current basis for this requirement does not take into account the different impact that different uses have on the traffic within the city. Attached to this request is a chart that outlines the different traffic counts that a particular use generates for a similar sized building to the clinic. Trip Generation data is readily available through the Transportation Engineers Trip Generation Manual and as you can see, the uses indicated vary from 60 ADT up to 3,812 trips. The impact of a convenience market of a similar size is significantly higher than that developed

Second, in researching this request, we looked at the Municipal Code for Payson City, Spanish Fork City, Springville City and Provo City. Through this research, we found that Provo City was the only city of those four who had a standard for requiring a second point of access.

Provo City Municipal Code Section 15.03.200 (14) requires "A development with a single street access (ingress and egress) shall have a minimum ADT not higher than two hundred fifty (250) vehicle trips. ADT shall be determined by trip generation rates obtained from the City Traffic Engineer. A second street access shall be required for projects which exceed the designated trip rate."

Third, the concern of the Owner is to provide a safe and easily navigable site for their patients, many of whom are elderly. Having two points of access onto this small site could be confusing to some. In addition, there is a



concern about having the two driveways on this site would create an unsafe condition with the driveways so close to each other. The configuration that is available for this site would place the driveways forty feet (40') from each other. While section 10-6-4, paragraph B of Santaquin's Municipal Code indicates that "Driveways shall be not closer to each other than thirty feet (30')," there is still concern that 40 feet cause issues to those trying to enter and exit from the site.

Finally, in working with our Traffic Engineer, Hales Engineering, they were unable to find any kind of established standard for the number of parking stalls that would trigger the need for a second point of access. Because of this, we pursued the option to provide a standard based upon the number of trips generated by the particular use.

One other consideration we reviewed was if there were any code requirements for access on to a site for the fire department. The 2015 International Fire Code (see image below) indicates that there are two times when the building code requires at least two means of egress for fire apparatus access at each structure – Condition one is when a building is more than 3 stories or 30 feet in height; condition two is when a building is greater than 62,000 sq. ft. if not sprinklered, or greater than 124,000 sq. ft. if sprinklered. Based upon this requirement, our building does not even come close to requiring a second access onto the site for fire department access.



The change in language was developed using the Provo City model as the basis for the requirement. We believe that this is the most consistent method for establishing the requirement for a second access.
