The Rowley Annexation Petition was submitted during the tenure of an earlier Council, therefore it may seem the current Council is being bypassed in the process. Council Member Broadhead stated he and Council Member Hathaway met with three Rowley Representatives. He wanted to make it clear that those representatives did not expect their annexation approval to hinge on their cooperation on future City projects. Council Member Broadhead requested the completion of any annexations be handled as quickly as possible and not span over different Councils.

DRC Items

- One February 3rd reviewed
 - 12 unit Park View Townhomes project at 300 West 200 South. Minor revisions needed before approval.
 - 32 unit Centennial Condos, mixed use project at 300 West 100 South. Several revisions and additional information needed before site plan approval. Architectural Review Committee approval also needed before permits allowed.
- On February 17th reviewed proposed 8 lot plat in core area. Includes multiple lot line adjustments and one new lot near 350 East 200 South. Will require PC but not CC review
- Meeting on February 24th with developers of Belle Vista Estates, 32 acre, 150 lot development near 600 North 400 East.
- March 3rd DRC meeting will include review of Foothill Village Preliminary Plat and
 possible Belle Vista Estates. These two projects require PC action and CC action before
 final plats can be submitted for review.

Planning Commission Items

Transportation Items

- <u>Impact Fee.</u> The City Council must hold a public hearing before implementing the Transportation Impact Fee. This hearing is noticed for the March 18 CC meeting.
- <u>Sunset Trails</u>. Final plans have been prepared for the Sunset Trails road and trail work.
 Bid for this work will be issued within 3 weeks. Funding source captured development bonds
- <u>500 East</u>. Mandatory pre-bid meeting held on February 17th. 8 companies attended. Bid closing is March 3, 2015. Agreement for exchange of right-of-way for 500 East has been finalized and sent.
