

The meeting was called to order by Mayor Kirk Hunsaker at 6:00 p.m. Council Members attending: Keith Broadhead, Mandy Jeffs and Nick Miller. Matthew Carr joined the meeting via telephone. David Hathaway arrived at 6:05 p.m. Keith Broadhead arrived at 6:06 p.m.

Council Member Miller moved to approve the Consent Agenda. Council Member Jeffs seconded the motion. The vote to approve the Consent Agenda was unanimous.

FORUM, BID OPENINGS, AWARDS, AND APPOINTMENTS

Police Chief Rod Hurst Oath of Office

Mayor Hunsaker reported that Rod Hurst, acting Police Chief, has accepted the position of full time Police Chief. There were a number of applicants, two of which came from within the department. A vote of confidence was extended to Mr. Hurst.

Council Member Jeffs moved to appoint Rodney Hurst as Santaquin's Chief of Police. Council Member Miller seconded the motion. Through a roll call vote, Council Members Hathaway, Carr, Jeffs, and Miller voted unanimously in favor of the motion.

Recorder Farnsworth administered the Oath of Office to Chief Hurst.

Chief Hurst thanked the Mayor and Council for the opportunity to serve as the Chief and being allowed to lead a fine group of officers. He thanked his family for their continual support.

Council Member Broadhead indicated he remembered when Chief Hurst was first hired. He said Chief Hurst "didn't have any mentoring and picked all this up on his own". Council Member Broadhead voiced his support of Chief Hurst. Council Members Hathaway, Miller, Carr and Jeffs also voiced their support of Chief Hurst and said they are looking forward to working closely with him and the other Santaquin City officers.

Council Member Carr ended the phone call in order to board his flight.

FORMAL PUBLIC HEARING

Public Hearing – FY2014-2015 Municipal Budget

Council Member Broadhead moved to enter into a Public Hearing with regard to the FY2014-2015 Municipal Budget. Council Member Hathaway seconded the motion. The vote to enter the Public Hearing was unanimous.

Council Member Broadhead asked a number of questions with regard to the content of the proposed budget. He requested the Purchasing Policy be put on a future agenda so a discussion can be held with regard to the spending limits allowed at the different levels.

The complete budget is available at the City Office for review.

Council Member Broadhead moved to close the Public Hearing. Council Member seconded Jeffs the motion. The vote to close the Public Hearing was unanimous.

NEW BUSINESS

Discussion and Possible Action with regard to the Fireworks Vendor

Orchard Days Chairperson Forman reported the committee has received approximately \$34,000 in financial donations and approximately \$5,000 in kind donations. Ms. Forman reported the committee made the decision to change fireworks vendors. The vendor selected is "Firestorm Pyrotechnics, Inc." Any contracts that need the Mayor's signatures will be placed on a future Council Meeting Agenda. (See attachment "A" for the proposal)

Ratification of Pole Canyon Road Sewer Lateral Project Bid

Assistant City Manager Marker reviewed the details of the Pole Canyon Road Sewer Lateral Project. The total cost to install sewer laterals to 6 existing homes along Pole Canyon Road is \$16,254. There will be an additional cost to stub an additional 400' beyond the proposed development. Installation of the additional piping will place the sewer closer to the proposed "Fish Pond". Council Member Broadhead was told a decision had not been made as to how to re-asphalt the road. Public Works Director Wade Eva indicated it may be less expensive to repave the complete road. A bypass road will be built along the fence line to keep the traffic moving.

Also discussed was whether or not the home owners should be required to pay a portion of the costs to run the sewer lines and laterals. No letters will be sent at this time to the property owners.

Council Member Broadhead moved to approve the contract with Greenhalgh Construction in the amount of \$16,254 for the Pole Canyon Road Sewer Lateral Project. Council Member Miller seconded the motion. The vote to approve the contract with Greenhalgh Construction was unanimous.

Training – Review of Municipal Financial Statements

City Manager Reeves provided training to the Mayor and Council Members on how to read and interpret the Financial Statements. The statements are always available at the City Office for the public's review.

Discussion and Possible Action with regard to the sale of municipal property

The discussion and possible action regarding the sale of municipal property was moved to a time following the Executive Session held with regard to pending or reasonably imminent litigation, and/or purchase, exchange, or lease of real property.

INTRODUCTIONS AND ADOPTION OF ORDINANCES AND RESOLUTIONS

Resolution 06-01-2014 "A Resolution Authorizing an Employment Contract with the Santaquin City Chief of Police"

City Manager Reeves reviewed the proposed contract with the Mayor and Council. Council Member Broadhead indicated he thought a contract would not be signed until the end of the six month probation period. City Manager Reeves stated the employee could lose all vested interest in his position if he did not have a contract. The employee would not feel he has the right to make changes or to move forward for fear he may not "make muster". Legal Counsel Rich indicated at this point it would not be to the advantage of the City to not approve the contract. Mayor Hunsaker recommended approving the Employment Contract and "chalk it up to a personal learning experience".

Council Member Jeffs moved to approve Resolution 06-01-2014, "A Resolution Authorizing an Employment Contract with the Santaquin City Chief of Police". Council Member Hathaway seconded the motion. Through a roll call vote Council Members Broadhead, Hathaway, Jeffs, and Miller voted in favor of approving Resolution 06-01-2014.

Resolution 06-02-2014 "A Resolution Adopting the FY2014-2015 Budget"

Council Member Broadhead asked if the transfer out of the Sewer Fund had increased over the last budget review. It was determined the transfers vary year to year.

Council Member Miller moved to approve Resolution 06-02-2014, "A Resolution Adopting the FY2014-2015 Budget". Council Member Jeffs seconded the motion. Through a roll call vote, Council Members Broadhead, Hathaway, Jeffs, and Miller voted in favor of approving Resolution 06-02-2014.

REPORTS OF OFFICERS, STAFF, BOARDS, AND COMMITTEES***City Manager Reeves***

City Manager Reeves reported he will be out of the office on Friday for a Family Reunion. He also reported Orem City is taking the lead in the fight against Gold Cross with regard to their Interfacility Transport Licenses. The Mayor and Council Members were in agreement to "join in the battle".

Assistant City Manager Marker

Assistant City Manager Marker reported on the following:

- The Planning Commission meeting on June 26 will include discussion about a possible 22 acre PUD development, the City's General Plan and possibly a revision to the Foothill Village development plans
- Matt Riffkin, the principal planner for the City's Transportation Consultant firm, passed away while on a family vacation. InterPlan is still working on the transportation plan and should have information back to us by the first of July.
- An agreement with Utah County is needed for funding the 500 East access project. Elections in November will affect who the City needs to engage with to put that agreement together.
- The bathrooms have been delivered to the Ahlin Pond property

Mr. Marker asked for clarification of the Council's direction on the planter boxes. Previous direction was to get numbers for replacing the materials with all real stone, but indications outside of the meetings were that a different direction was desired. The Council again expressed concerns about using the faux stone and the likelihood of any applied materials having limited maintenance.

Mayor Hunsaker related a conversation with investors from California who praised Santaquin's efforts to beautify the City. The Mayor expressed a desire to maintain the high quality look of the enhancements in place. Councilmember Hathaway shared his opinion about any stone needing to not be dry stacked and concerns about material permeability. Councilmember Jeffs indicated she still thinks the boxes need to be removed, but if they are going to remain, the City should consider the lower cost option of foundation rubbing. Mr. Marker asked if staff should get pricing for both the rubbing and the real stone options. The Council indicated that staff should get pricing on those two options and bring the information back for further discussion.

REPORTS BY MAYOR AND COUNCIL MEMBERS

Mayor Hunsaker

Mayor Hunsaker reported there is a need for two new Library Board Members. The terms for Board Members Chad Argyle and Michelle Moser will be completed in July. Mayor Hunsaker met with Katie Blake and Dayne Dickey who both agreed to serve on the Board. Approval will take place at a future Council Meeting.

Council Members

Council Member Hathaway was told that, now the budget has been approved, City Manager Reeves will contact a Structural Engineer to review the structural soundness of the old building. Mr. Reeves will then schedule a joint meeting with the Museum Board.

Council Member Hathaway was told July 16th is the date of the "Meet and Great" for the citizens.

Council Member Hathaway also reported he attended the Seniors' lunch this past Thursday. They are worried that the "home cooked" meals will soon be a thing of the past. The Mayor and Council were in agreement that the meals would not be supplied by "Meals on Wheels".

The Salary Review Committee has met two times. They are planning to meet again in a week. Additional information will be presented as it is available.

Council Member Miller reported he met with the Representatives of Allied Waste. They stated they are still interested in meeting with the Council Members to discuss recycling.

The Economic Summit will be held at the Chillon Reception Center in Spanish Fork. The event will begin at 9 a.m.

Council Member Miller indicated he has had ball players' parents question why the restrooms have not been opened during the games. Council Member Miller would like to reevaluate opening the restrooms next year even if it means having someone on the premises when they are open.

Council Member Broadhead is in charge of the Poker Run this year. He is soliciting ideas as to how to incorporate stopping at businesses throughout the City. The Mayor and Council Members indicated they would be willing to help if needed.




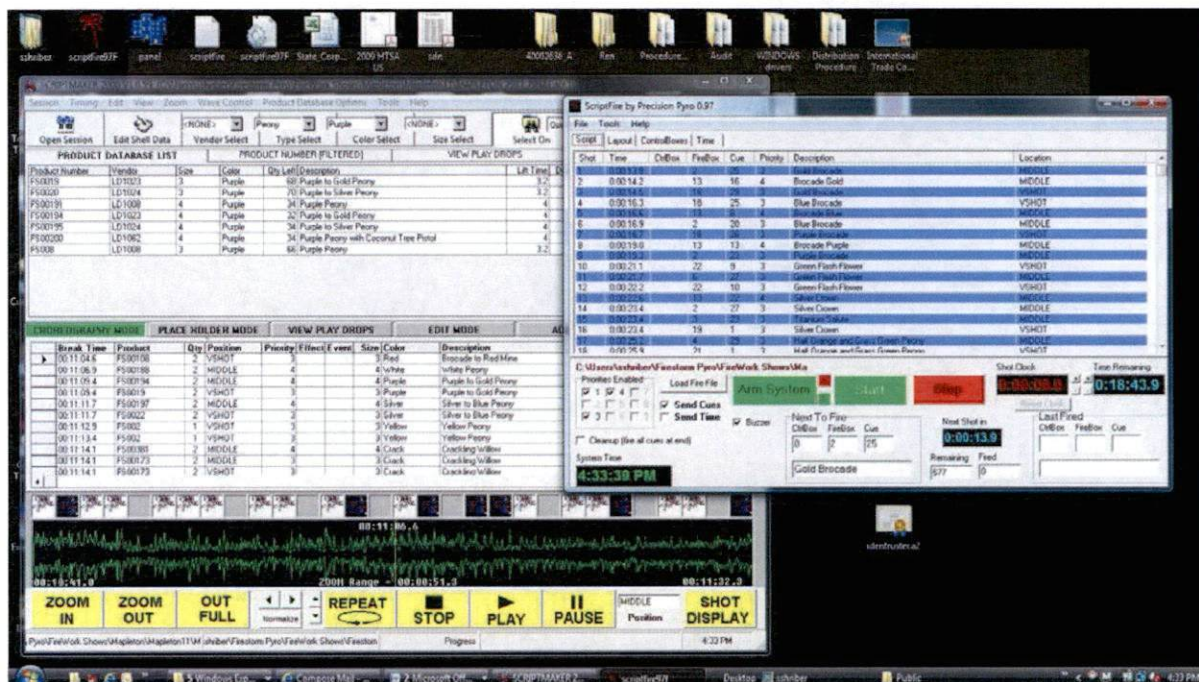


Figure 1: Screen shot of Firestorm's Control System in action

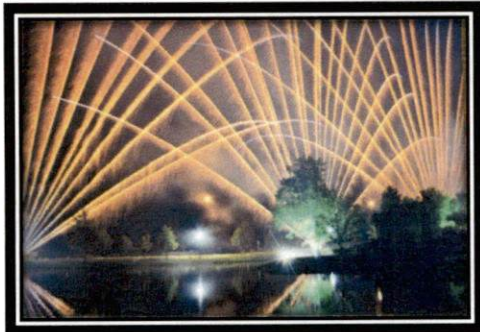

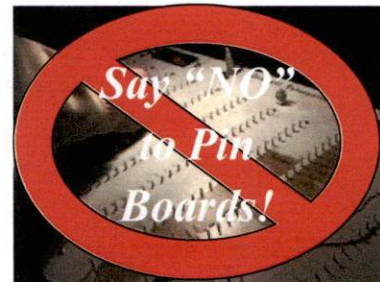

We create stacked shots with our precise timing that others simply cannot do.

Example: A cloud of Golden Falling Willows at 600ft as they fall past 500ft we burst a dispersed cloud of Silver Falling Leaves. Every shot in our show will have this level of detail to create a symphony in the sky of spectacular sparkling fire, color, light and sound, choreographed precisely to your music.

Your show will be completely coordinated by our state-of-the-art, proprietary, computer control system. We adjust the pace of the production real-time to ensure that the choreography of the shells remains synchronous with the rhythm of the music regardless of music playback variation.

Some fireworks companies say they have computer-choreographed and computer-controlled shows. They *may* have used a computer to catalog and select their products for a show, but don't believe them when they say it is computer controlled. The vast majority of our competitors use pin boards to launch their product. What good is a computer designed and timed show if it's not computer controlled? Our proprietary control system will synchronize the launch from multiple locations in your display area, digitally-timed with the script and choreographed to music.

Since our beginning in 2006, Firestorm is the only firework company with Safe Fire technology. Our proprietary computer controlled firing system detects if mortar tubes lose integrity or change in position and at the speed of light restricts the firing of any product from those mortars. It is very unusual to have a problem like this but safety is the first consideration.

Firestorm's products are custom made. We do not purchase assorted cases like many fireworks companies. This means we stock more pyrotechnics and have 4 times the selection of different effects. We have over 800 different firework types in each size. If Firestorm is selected to provide your shows, we will script each show from our inventory and provide a detailed list of effect descriptions by shell size, if requested.

Firestorm is also unique in the fact that we use full length mortar tubes. NFPA 1123 does not recommend or control mortar tube length. Almost all firework companies use short tubes to save money. Mortar tube length directly affects the height of the fireworks. Firestorm mortar tubes are all the correct length and the result is our fireworks go higher and look bigger.

FIREWORK DISPLAY OPITIONS

Show pricing is highly dependent on your individual preferences in theme, number of mortar field locations, fall-out area sizes, and field of view for your guests. Please keep in mind that we can shoot multiple firework displays, thousands of feet apart from one computer. For example, in St. George we shot pyrotechnic effects 4" and smaller from a down town location and 4"- 12" pyrotechnic effects from two locations on the surrounding mountains 4000' to 5000' away. We can provide options for multiple shoot locations if it will benefit you.

Proceed with caution with any vender that lists the exact type of product that will be used in your show at this stage. We custom choreograph each shot to fit your music and theme. We cannot provide the exact product we will use until we have the music and theme. This is a key defining factor in choosing the best firework vendor.

There are many firework manufactures. The saying "you get what you pay for" is especially true in the firework industry. Many firework companies buy the least expensive product; we refuse to do this for safety and quality reasons. In addition, we want you to have the best products available. For example a 4" Aqua Ghost Shell (<http://youtu.be/FRMJgxxnU9E>), or 4" Triple color-changing Japanese shell (<http://youtu.be/7rnlnUzyxPE>). These products can cost 4-8 times as much as a standard effect. If quantity is all you care about, we are not that firework company.

Like Paul Anderson, Owner of radio stations KZBQ, KORR and KOUU, said, "There are going to be more shells, and larger shells, but most of all it's what they can do with it. It's like having a better paint brush."

Firework companies quote different ways. We count one shell with multiple brakes as one shell. Some vendors use a different method, be cautious, any other way is difficult to audit.

The following product quantities represent a quality firework display with multiple shot volleys of layered matched colors and varied patterned explosions of color to paint the sky with wonder. We offer you an unsurpassed quality that you can count on to be safe.

SHOW PRICING AND DURATION

A typical pyrotechnic fireworks show will last 20 minutes – the industry rule-of-thumb for audience attention span. However, with music variation, change of pace, false finales and other interesting effects, times of 30 minutes are not unreasonable or uncommon.

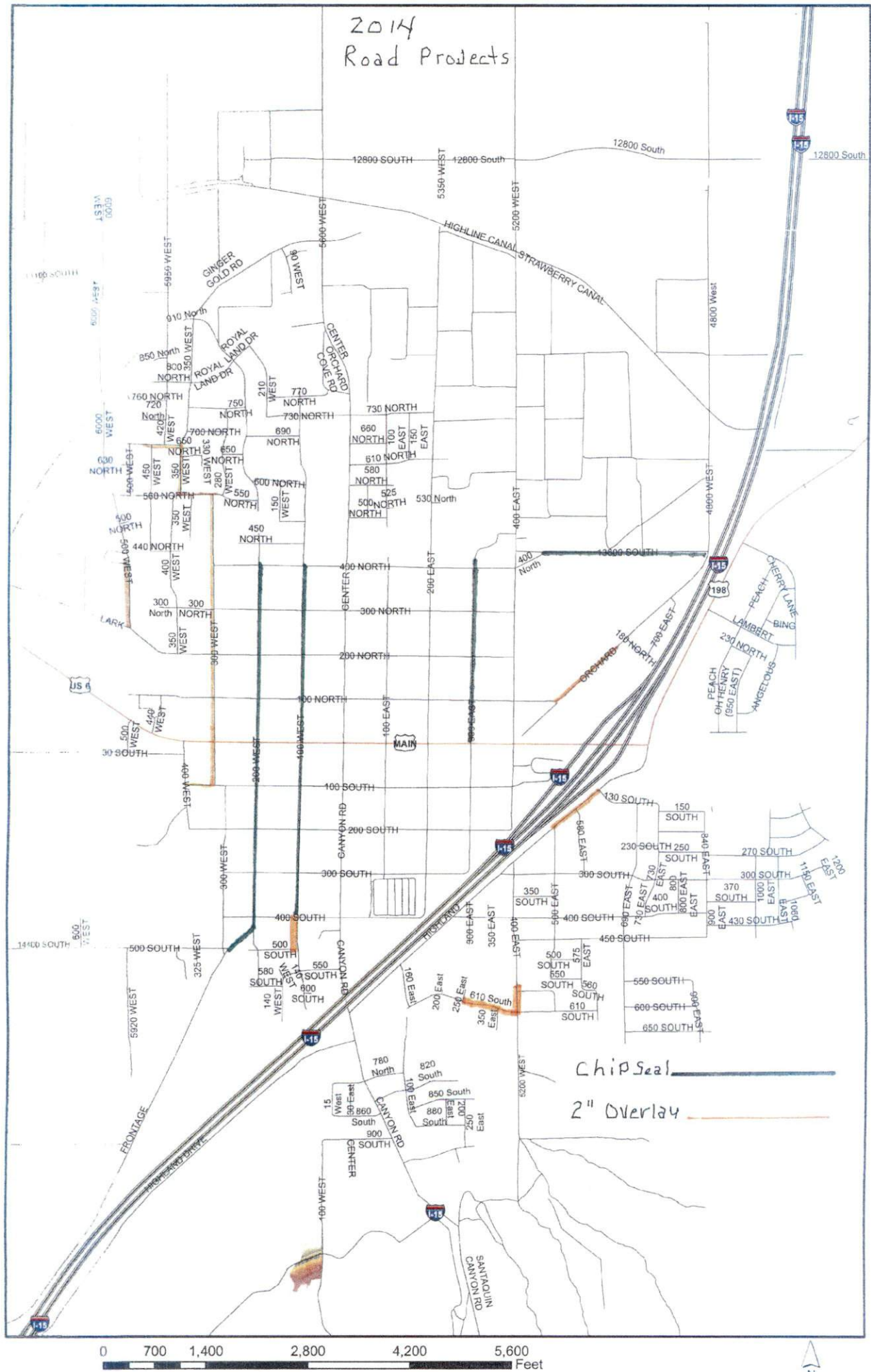
