MINUTES OF A COUNCIL WORK SESSION HELD IN THE COUNCIL CHAMBERS AUGUST 14, 2013

The meeting was called to order by Mayor James E. DeGraffenried at 6:03 p.m. Council Members attending: Keith Broadhead, Matthew Carr, Kirk Hunsaker, James Linford and Rick Steele.

Others present: City Manager Ben Reeves, Fire Chief Stephen Olson, Battalion Chief Ryan Lind, Public Safety Director Dennis Howard, Public Works Director Wade Eva, Planning Commissioner Nick Miller, Maurine Ross, Marianne Stephenson, Denise Rohbock, Doug Rohbock, and Bruce Houser.

DISCUSSION ITEMS

Agenda Review

Mayor DeGraffenried indicated an action needed to be made on the proposed tax rate increase.

Council Member Hunsaker stated he has gone back and forth trying to make a final decision. He would like to hear what the other Council Members are thinking.

Council Member Carr has reviewed the issue in depth. He thinks it is irresponsible to do nothing. He proposed starting at a 25% increase and finding an additional 25% within the current budget.

Council Member Steele echoed Council Member Carr's thoughts. He thinks a gradual increase is something he could support.

Council Member Broadhead reminded everyone that he has stated in the past that he would not support an increase unless the monies raised were guaranteed to be used for road maintenance, as well as having the issue placed on the ballot. He thinks the current budget needs to be reviewed and needs versus wants need to be evaluated. He is of the opinion that the city structure is "top/director heavy". He feels there may be cuts that can be made in the Leisure Services and Community Development Departments.

Council Member Linford reported he was not present at the public hearing but he has received a number of e-mails and phone calls pertaining to this issue. He "was ok with a 50 to 75% increase" in order to make a greater impact on road repairs or replacements.

Mayor DeGraffenried went back to Council Member Hunsaker. Council Member Hunsaker indicated the majority of those he has talked with are ok with a tax increase, just not at 100%. He understands the thoughts of all the Council Members and would support an increase.

Mayor DeGraffenried stated he would support an increase. He feels 50% is a fair number. He indicated citizens would prefer a gradual increase with a current budget review. He reminded the Council Members that in hard times the budget was trimmed by 10% and then it was cut by an additional 7%. He stated would support any decision of the Council Members. He also stated the Council Members could pass an Ordinance to assure the money be used appropriately until the issue is put on the ballot next year.

Mayor DeGraffenried continued by saying office hours have been reduced and the office is being closed at 1:00 on Fridays to help reduce costs.

Council Member Broadhead mentioned there doesn't need to be a Recreation Department but there does need to be roads to drive on.

Council Member Steele commented that the Construction Standards have been improved over the years and the public needs to know that.

Director Eva reported the extra funds allowed for road maintenance have been used wisely. Tightening of the Constructions Standards has helped greatly. He would like to continue to gain on the road maintenance instead of falling behind.

Further discussion will be held during Council Meeting if warranted.

The City Council Agenda was reviewed. It was determined that items 7b; Resolution 05-03-2013, A Resolution approving amendments to the Ahlin Property Annexation and Development Agreement and 11a; Ordinance 07-02-2013, An Ordinance modifying Multi-Family Development Standards were not ready and should be tabled.

General Discussion

Chief Olson updated the Mayor and Council Members on how the Wildland Season is progressing. He reported there are new fires daily. The department received a request for a full Paramedic Ambulance to respond to the fire in Malad, Idaho. He reported the request would be fulfilled and the crew would report to the fire IC the next morning. (See attachment "A" for the presentation)

Council Member Carr was told deployment of any City resources "is a money maker for the Department". He voiced his support of the deployment.

Council Member Broadhead was told the fires could be either a State or Federal Fire but the recently adopted MOU covered both.

City Manager Reeves stated the personnel reimbursement would be included in the funds obtained from sending the resources to the fire line. The question was asked about how the wages would be paid. City Manager Reeves indicated the wages could be set by Resolution.

Council Member Broadhead was told with one of the City's ambulances out of town, the Goshen rig would be used as back up. He asked if it would be staged at our station or in Goshen. It could be staged at either facility.

With no further discussion, the meeting adjourned at 6:45 p.m.



WILDLAND DEPLOYMENTS



- Santaquin fronts expenses for fuel, travel, and resource equipment
- Full reimbursement could be delayed for up to 6 months
- Reimbursement for travel expenses
 - Meal Per Diem at local rate
 - Lodging at actual cost

OTHER BILLING AND COST RECOVERY TRAVEL REIMBURSEMENT

- Department priority is to provide adequate fire & EMS service levels to protect Santaquin's residents, businesses, and guests
- Many current firefighters have flexible enough employment schedules to deploy
- When staffing levels can't be maintained, crews will not be deployed out of the area
- Firefighters can't commit to a 16 day deployment without having an established compensations plan
 - May be possible to swap personnel during tour


