MINUTES OF A COUNCIL WORK SESSION HELD IN THE COUNCIL ROOM JUNE 12, 2013

The meeting was called to order by Mayor James E. DeGraffenried at 6:00 pm. Council Members attending: Keith Broadhead, Kirk Hunsaker, James Linford, and Rick Steele. Matthew Carr was excused.

Others attending: City Manager Ben Reeves, Legal Counsel Brett Rich, Director Dennis Howard, and Director Wade Eva.

DISCUSSION ITEMS

Discussion – Pressurized Irrigation System and possible delivery of personally owned shares of irrigation company water

City Manager Reeves reported Dan Olson had spoken to him with regard to an open ditch located in front of his father's property. During the discussion, he also asked if it would be possible to receive his Summit Creek Water Shares through the Pressurized Irrigation System. An e-mail was sent to the Council Members which was originated by Mr. Olson asking that his request be discussed. Anyone who owned a share of Summit Creek Share would be allowed to receive the water this way if Mr. Olson's request was granted. It was questioned if the system could handle such a request and if the system could handle the extra water, what would the cost be, would this cause an accounting nightmare, would the pressure on the Eastside decrease, and would the City acquire the voting right of each share. Council Member Linford doesn't like that there would be additional stress on the system. Director Eva reported the Center Street well was "fired up" last week and the 400 North booster pump "fired up" on Tuesday; that is the kind of load that is on the system right now. Director Eva doesn't see problem if they are watering their residential property. He indicated the system could not handle watering farmland. Council Member Linford indicated the issue had been discussed in the past and was decided against. Council Member Broadhead guestioned why the City would subject themselves to being required to deliver water to the shareholders when there may not be water to deliver. Council Member Broadhead indicated he would be in favor of letting someone receive their Summit Creek Shares through the P.I. System if there is a hardship on actually receiving their water through a ditch. The comment was made that there would be additional pumping costs due to the additional water needed. It was decided the City would not allow privately owned Summit Creek Shares to be delivered through the P.I. lines.

Also reported was Glade Robbins had sent an e-mail to the City Manager indicating his pressurized irrigation line was blowing air instead of delivering water. A discussion was held as to whether to allow them to use culinary water at pressurized irrigation rates. The general consensus was to have Director Eva and City Manager Reeves "work out" the issue so Mr. Robbins can receive the needed water.

Director Eva reported the RV dump "is a mess". Without the grate, the system gets plugged by trailer discharge hoses. Director Eva was asked to "come up" with several options to present to the Mayor and Council.
