Council Member Linford made a motion to approve the Consent Agenda. Council Member Hunsaker seconded the motion. Council Members Broadhead, Carr, Hunsaker, and Linford voted unanimously to approve the consent agenda.

Mayor DeGraffenried said he would like to appoint Chante Hammond and Jolynn Forman as the chairs for the Orchard Days Committee. Ms. Forman introduced herself and shared her enthusiasm with the Council.

Council Member Carr made a motion to appoint Chante Hammond and Jolynn Forman as Cochairs of Santaquin City Orchard Days Celebration. Council Member Hunsaker seconded the motion. Council Members Broadhead, Carr, Hunsaker, and Linford voted unanimously to approve the motion.

FORMAL PUBLIC HEARINGS

REPORTS OF OFFICERS, STAFF, BOARDS, AND COMMITTEES

Dennis Marker said the Planning Commission had cancelled their February 14 meeting, and will meet on the 28th, in order to continue with the General Plan review.

The Community Center Committee met on February 5, and spent the meeting reviewing pictures of other recreation centers, including what type of issues had arisen at the centers and what comments and advice the center directors had given. The Committee will meet again on February 19 to review community desires and formulate what they would like to see happen.

Ben Reeves said the City staff was presently moving forward quickly with employee evaluations and working to put budget requests together.

NEW BUSINESS

Discussion and Possible Action with regard to Change Order (4) of the Santaquin Wastewater Reclamation Facility Project

Ben Reeves said there is a proposed \$4,200 increase in this order due to issues with the fire alarm system and blower revisions. Piping configuration changes have been required in a move that will increase the capacity of the system without changing the footprint of the building. Also included is a credit for a removed duplication on order 3, which gives this Change Order a net credit of \$3,100.

Council Member Linford made to approve Change Order 4 of the Santaquin Wastewater Reclamation Facility Project. Council Member Carr seconded the motion. Council Members Broadhead, Carr, Hunsaker, and Linford voted unanimously to approve Change Order 4.

INTRODUCTIONS AND ADOPTION OF ORDINANCES AND RESOLUTIONS

Resolution 02-01-2013 "A Resolution Declaring Surplus Property of Santaquin City" Ben Reeves said this surplus property deals with the replacement of computers. All the replaced computers have been wiped clean, and useable ones will be sold.

Council Member Hunsaker made a motion to approve Resolution 02-01-2013, "A Resolution Declaring Surplus Property of Santaquin City". Council Member Linford seconded the motion. By a roll call vote, Council Members Broadhead, Carr, Hunsaker, and Linford voted unanimously in favor of approving Resolution 02-01-2013.

REPORTS BY MAYOR AND COUNCIL MEMBERS

Council Members

Council Member Linford said the last SUMWA meeting included a discussion with the mayors of various cities concerning recharge and the Highline Canal. Documents regarding this discussion will be sent to the City, and a copy of the proposed agreements distributed to the City Council.

Mayor DeGraffenried said SUMWA has to go through city governments to approve funds spent by the cities.

Council Member Hunsaker asked if SUNROC had gotten back to the City yet. Mr. Marker said City Planner Greg Flint was working with SUNROC and planned to meet at the site tomorrow to look at the road. As of today, he has not heard back from SUNROC on the terms of the agreement.

Council Member Broadhead asked if there was any way to get an update of the overall budget on the sewer. Mr. Reeves said he could have JUB Engineering put together a line item budget if the Council wanted.

Council Member Broadhead asked if the gas line would be in the budget. Mr. Reeves said an analysis had been done, and there would be a five year payback on the gas line, which would bring a savings to the City of approximately \$8000 a year. There is a larger upfront cost, which the project would pay for. Another advantage would be that if the public works building is built at the same location, the gas line could easily be extended there.

Mr. Reeves said he had asked Trevor Lindley to put together a certain number of cartridges at the end of the project. If there are project funds available at the end, it would make sense to buy enough cartridges to completely fill all the trains and maximize capacity.
