REPORTS BY MAYOR AND COUNCIL MEMBERS

Mayor DeGraffenried

Mayor DeGraffenried reported he has asked Martin Green to work with the Miss Santaquin Pageant Committee. Mr. Green has accepted the assignment.

Council Members

Council Members Hunsaker and Broadhead offered thanks to the Public Works Department for completing the road striping throughout the City. It was reported the project was completed under the estimated budget.

City Manager Reeves reported the following:

- A change to the Fee Schedule will be presented again in the month of January. This
 change will reflect the established CPI increase associated with the base rates charged
 for utilities.
- A survey is required every three years for the CDBG Grant. The project proposed is a Seniors Center Feasibility Study Plan that would be in coordination with the Recreation Center.
- A window was broken at the Library. The original one piece specialty windows are being replaced one by one with a less expensive, two piece window. The design of the less expensive window correlates nicely with the original windows.
- Employee evaluations will be completed during the month of January
- The Quiet Zone Resolution adopted at the city level needs to be reflected in an Interlocal Agreement with the County. The Interlocal Agreement will be presented to the Council for adoption at a later date.
- Genola Representatives have requested Santaquin City purchase their water main along Lark Lane, which delivers the court-ordered 100 gallons per minute. When a proposal is drafted by the Genola Representatives, it will be presented to the Council for their consideration.
- The Resolution regulating the detonation of fireworks expired October 1st. Detonations during the holidays are required to follow State guidelines.
- The City Offices will be closed December 25 and 26 as well as January 1 in observance of the holidays.
- Director Howard met with Juab County Sherriff to review a proposed Mutual Aid Agreement. The agreement will address all Public Safety mutual aid needs.
- The "Hotel coming in 2010" sign located by the Dairy Queen has been removed.

Director Marker reported that he, City Manager Reeves, Council Member Steele and Leisure Services Director Schmidt met to discuss putting together a committee to help with a study for a Community Center. A group of approximately 15 community residents has been for asked to serve on this committee. The "kick-off" meeting is scheduled for Thursday, December 20th in the Council Chambers to discuss the process.

It was reported that the 18" sewer line is to manhole #10, and is moving right along. To this point there has been 17 trees removed. Additional easements will be needed on the Rowley property to continue with the project.
