Council Member Payne moved to ratify Change Order #1 of the 2012 Park Improvements

Linford, Payne and Steele voted unanimously to ratify Change Order #1.

Discussion and Possible Action with regard to the purchase of 18 shares of Summit Creek Irrigation

Mayor DeGraffenried removed himself from the stand and turned the direction of the meeting to Mayor Pro-tem Payne. He indicated he was doing so because he is the owner of the water shares being discussed.

City Manager Reeves reported that historically the purchase of Summit Creek Irrigation water shares was handled administratively with the consent of the Mayor. Because the shares belong to Mayor DeGraffenried, authorization to make the purchase of the shares was being handled this way. Council Member Broadhead was told the City's Water Engineer is consulted before any purchase is completed.

Council Member Linford moved to authorize the purchase of 18 shares of Summit Creek Irrigation Water at \$3,900 per share. Council Member Carr seconded the motion. Council Members Broadhead, Carr, Linford, Payne and Steele voted unanimously to approve the motion.

Dear Mayor and Council Members

For the past few years we have been able to secure grant money which paid fifty percent of the cost of our body armor. The Department of Justice has now made it policy that in order to qualify for this money the Police Department must have a mandatary wear policy.

You will find attached to this letter our department Policy which meets the requirements of the Department of Justice.

This policy does require Council approval due to the financial impact associated with rotation of expired body armor. The National Institute of Justice requires body armor to be rotated every five years. We currently have three vests that have expired. We will need one more during the upcoming year for the new hire.

GENERAL ORDER 11-7

BODY ARMOR

Effective 2011

I. PURPOSE

The purpose of this policy is to provide Santaquin Police Officers with guidelines for the proper use and care of body armor.

II. POLICY

It is the policy of Santaquin Police Department to maximize officer safety through the use of body armor in combination with prescribed safety procedures. While body armor provides a significant level of protection, it is not a substitute for the observance of officer safety procedures.

III. DEFINITIONS

Field Activities: Duty assignments and/or tasks that place or could reasonably be expected to place officers in situations where they would be required to act in enforcement rather than administrative or support capacities.

IV. PROCEDURES

- A. Issuance of Body armor
 - 1. All body armor issued must comply with protective and related requirements prescribed under current standards of the National Institute of Justice.
 - 2. All officers shall be issued agency approved body armor.
 - 3. Body armor that is worn or damaged shall be replaced by the agency. Body armor that must be replaced due to misuse or abuse by the officer shall be paid for by the officer.
- B. Use of Body Armor
 - 1. Officers shall wear only agency approved body armor.
- C. Inspections of Body Armor.
 - 1. Supervisors shall be responsible for ensuring that body armor is worn and maintained as required by this policy through routine observation and periodic documented inspections.
 - 2. Annual inspections of body armor shall be conducted for fit, cleanliness, signs of damage, abuse and wear.
- D. Care, Maintenance and Replacement of Body Armor
 - 1. Officers shall routinely inspect personal body armor for signs of damage and for general cleanliness.
 - 2. As dirt and perspiration may erode ballistic panels, each officer shall be responsible for cleaning personal body armor in accordance with the manufacturer's instructions.

- 3. Officers are responsible for the proper storage, maintenance and care of body armor in accordance with manufacturer's instructions.
- 4. Officers are responsible for reporting damage or excessive wear to the ballistic panels or cover to their supervisor and the individual responsible for the uniform supply function.
- 5. Body armor will be replaced in accordance with guidelines and protocols established by the National Institute of Justice.

E. Training

The training officer shall be responsible for:

- 1. Monitoring technological advances in the body armor industry that may necessitate a change in body armor.
- 2. Assessing weapons and ammunition currently in use and the suitability of approved body armor to protect against those threats.
- 3. Providing training programs that demonstrate body armor's stopping power under actual firing conditions and that emphasize its safe and proper use.
- 4. Maintaining statistics on incidents where armor has or has not protected officers from harm, including traffic accidents.

General Plan

GOALS OF THE ENVIRONMENTAL PLAN ARE:

Goal 1: Limit disturbance of hillside areas having 30 percent or steeper slopes.

Goal 2: Prepare and adopt a hillside development ordinance.

Goal 3: Minimize soil and geologic hazards to people and properties.

Policy 1: Establish special review procedures and ordinances for building on hillsides or in other environmentally sensitive areas.

Policy 2: Require developers to have qualified professionals identify and assess soils and geologic hazards prior to development.

Policy 3: Construction standards and guidelines for roads and other improvements should be established to limit impacts on sensitive hillsides.

Policy 4: Regulate development densities in areas that are determined to have geologic hazards or constraints.


 ${\it Goal 5: Implement\ Wildland\ Urban\ Interface\ standards\ for\ new\ development.}$

Policy 1: Work with other public agencies to establish and implement fire hazard reduction measures.

Policy 2: Work with other public agencies to protect winter range habitat for big game animals.

Policy 3: Existing open spaces should be identified and preserved on a priority basis.

Policy 4: Provide and cooperate with other public changes for low impact public recreation facilities.

History of Hillside Development Overlay Zone

Ordinance Adoption


The City Council created the Hillside Development Overlay Zone in September 2011, with an effective date of 9-22-2011 (Santaquin City Code (S.C.C)).

Planning Commission
The Planning Commission discusses the Hillside Ordinance during the January 12th and January 26th meetings regarding the placement of the zone. A public hearing was held on February 9th. On May 24th, a tour of areas in question was conducted and further discussion was held. The Planning Commission forwarded the rezoning boundary with a positive recommendation to the City Council.

History of Hillside Development Overlay Zone

Placement of the Hillside Development Overlay Zone


Criteria to evaluate areas in the zone include "areas which are prone to geologic hazards, within state identified potential surface fault rupture zones; exceed thirty percent (30%) slopes; are designated wetlands, watershed or water source protection areas; areas of historical significance; or as may otherwise be determined to be necessarily protected by official action of the city, county, state or a federal agency" (S.C.C. 10-7Q-3).



What is an Overlay Zone?

It is also the intent of this article that the hillside zone be an overlay zone with densities and land uses being established by underlying zoning. It is also intended that any developer demonstrate by the applications submitted for approval that the objectives and goals of the general plan, the underlying zone and this section will be fostered. (S.C. C. 10-7Q-1)

Land uses allowed within the hillside development zone are listed in the respective underlying zones (S.C.C. 10-70-4)





Overlay zoning is a regulatory tool that creates a special zoning district, placed over an existing base zone(s), which identifies special provisions in addition to those in the underlying base zone. The overlay district can share common boundaries with the base zone or cut across base zone boundaries. Regulations or incentives are attached to the overlay district to protect a specific resource or guide development within a special area.



Impacts of Zone

The purpose of the hillside development zone is to establish standards for development in environmentally sensitive or geologically hazardous areas associated with foothill or steep terrain areas within the city. Additional goals in establishing this zone are as follows:

- A. Promote sustainable design criteria for new developments which address long term impacts of development in sensitive areas.
- B. Provide flexible development options where a standard lot pattern is not practical or desirable due to natural topographic constraints or conditions caused by mass grading or excavation activities on a site.
- C. Provide for the preservation of wildlife corridors and natural drainage channels or systems and the use of measures to protect future property owners from geologic and fire hazards as development occurs in sensitive areas.
- D. Provide for the reestablishment of vegetation and reclamation of barren areas caused by mass grading, excavation activities or development in sensitive areas.





Subdivision lots with existing structures, houses, etc.






Proposed Rezoning to Hillside Development Overlay Zone
