# Discussion and possible action with regard to a resolution of the Election Contest

Council Member Carr moved to authorize a settlement of pending and potential claims regarding the financing and construction of the proposed MBR facility which is the subject of Proposition 1 and Proposition 2 of the 2011 Santaquin Municipal General Election on the following terms: City would pay \$100,000 payable within 30 days of commencement of construction, City will also establish an advisory committee to work with the fruit growers to mitigate adverse effects of the facility on the Global Good Agriculture Practice (GAP) Compliance, and contingent on an agreement to waive and not pursue any claims related to the financing and construction of the MBR Facility. This agreement would cover the claims of Keith Broadhead, Kenyon Farley, William Ferguson, and companies associated with them. The offer will expire at 12 noon, Wednesday, February 8, 2012. Council Member Payne seconded the motion. Council Members Carr, Linford, and Payne voted in the affirmative through a roll call vote.
