MINUTES OF A CITY COUNCIL MEETING HELD IN THE COUNCIL CHAMBERS FEBRUARY 1, 2012

The meeting was called to order by Mayor James E. DeGraffenried at 7:00 pm. Council Members attending: Keith Broadhead, Matthew Carr, Richard Payne, and Rick Steele.

Others attending: City Manager Ben Reeves, Legal Counsel Brett Rich, Community Development Director Dennis Marker, Public Safety Director Dennis Howard, Leisure Services Director Kevin Schmidt, Amy Johnson, Doug Rohbock, Rock Haun, Spencer Healey, Martin Green, Nick Miller, Mayke Wood, Trevor Wood, Emery Openshaw, Chase Openshaw, and other unidentified individuals. Vince Rampton, Phil Rowley, Marc Rowley, Chad Rowley, and Kenyon Farley arrived after the meeting began.

Council Member Steele moved to approve the Consent Agenda. Council Members Carr seconded the motion. Council Members Broadhead, Carr, Payne and Steele voted in the unanimous.

FORUM, BID OPENINGS, AWARDS, AND APPOINTMENTS

Mr. Healey, reporter for "Insantaquin", reported they are currently live streaming the Council Meeting. There is availability for live chats and/or comments and is wondering if the Mayor and Council would entertain questions during the Council Meeting. Mayor DeGraffenried will hold a discussion with the Council Members and let them know. Mr. Healey also indicted they currently use 3g and 4g for the live stream which is "choppy at times". He is requesting permission to use one of the City's two Wi-Fi connections which would help with the live feed. Mr. Healey was told currently there is an issue with separating "Guest access" from the City's services. City Manager Reeves indicated there will be equipment installed shortly with will allow the requested access.

Mr. Green addressed those in attendance. "A couple of things I would like to bring up tonight, Mayor. It is my understanding that this past week, this has to do with the sewer lawsuit; my understanding was there was a Judge in the 4th District Court that recounted that vote. Is that correct"? Mayor DeGraffenried indicted his understanding was correct. Mr. Green asked if we knew how that turned out. He was told the Judges recount numbers were the exact as the County's recount numbers. Mr. Green continued "I know as a City Council there is an individual that was...trying to use the right words. Basically what I am hoping for is that those that attacked our City Recorder and questioned her judgment, I hope that there is some public apologies to that". Mr. Green asked Council Member Broadhead "I'm wondering since you are the one who brought the lawsuit to the City, as a sitting City Council Member are you either going to withdraw the lawsuit or are you going to resign from being on the City Council". Council Member Broadhead indicated "I'm not going to resign; the lawsuit was going when I was elected". Mr. Green said "for over 2 years I've listen to a lot of people asking the question if we are going to unify the City. So

my question is with the Judge doing that recount, are we going to unify the City and drop the lawsuit or are we going to keep playing games and keep going forward with the this"? Council Member Broadhead said, "no comment". Mr. Green concluded by saying "that's what I thought".

Appointment of a Mayor Pro-Tem

Mayor DeGraffenried requested nominations for the Mayor Pro-tem. Council Member Broadhead nominated Council Member Payne. Council Member Carr seconded the nomination. Council Members Broadhead, Carr and Steele voted in favor of the motion. Council Member Payne "voted silently in his head".

Appointment of the City Recorder

Council Member Carr moved to reappoint Susan Farnsworth as the City Recorder. Council Member Payne seconded the motion. Council Members Broadhead, Carr, Payne and Steele voted in the unanimous.

Appointment of the City Treasurer

Council Member Payne moved to appoint Ben Reeves as the City Treasurer. Council Member Steele seconded the motion. Council Members Broadhead, Carr, Payne and Steele voted in the unanimous.

Appointment of Members of the Architectural Review Committee

Mayor DeGraffenried recommended reappointment of Tim Ringger for a 3 year term and Carolyn Callahan for a 2 year term, appointment of Planning Commission Member Nick Miller for a 2 year term and Director Marker for a 3 year term to the Architectural Review Committee.

Council Member Broadhead asked what actually the Architectural Review Committee is. Director Marker indicted the Architectural Review Committee was established by the City Council to review applications primarily for multifamily developments and commercial developments in the C-1 Zones and the Main Street area. Since the committee was created there have been 6 twin homes that they have reviewed. They reviewed the 6-plex that is currently under construction on the North end of town as well as the site plans for the Dairy Queen. It is a group, as an application is submitted to the Development Office, the Committee is required to meet within 10 days to review the application and review the standards adopted in the ordinance. There is some flexibility the Committee has been given in the ordinance as to looking at the intent of the ordinance as well as the actual language. Council Member Broadhead asked if it was an advisory committee to the Planning Commission. "When does this trigger"? Director Marker said the Planning Commission does not review site plans. This would be the responsibility of the Committee. They would make sure the development meets the standards of the City. They are not an advisory board. They are an Administrative Function. Any appeals of their decision would be heard by the City Council.

Mr. Rohbock was told currently there weren't any property owners living along Main Street who serves on the committee. In jest Director Marker said "I think Mr. Rohbock is volunteering Mayor".

Council Member Carr moved to appoint Director Marker and Tim Ringger for 3 year term, Carolyn Callahan and Nick Miller for 2 year terms to the Architectural Review Committee. Council Member Steele seconded the motion. Council Members Broadhead, Carr, Payne and Steele voted in the unanimous.

FORMAL PUBLIC HEARINGS

Adjustment #1 pertaining to the FY2011-2012 Budget

Council Member Payne moved to open the Public Hearing with regard to Adjustment #1 pertaining to the FY2011-2012 Budget. Council Member Carr seconded the motion. Council Members Broadhead, Carr, Payne and Steele voted in the unanimous.

City Manager Reeves review with those in attendance the proposed adjustments to the current budget. (see Resolution 02-01-2012 for an outline of the adjustments)

At 7:32 pm Council Member Steele moved to close the Public Hearing. Council Member Payne seconded the motion. Council Members Broadhead, Carr, Payne and Steele voted in the unanimous.

It was reported there was a new Business License issued Dale Ashcraft, D.B.A. DCA Surveying.

REPORTS OF OFFICERS, STAFF, BOARDS, AND COMMITTEES

Planning Commission Member Mr. Miller reported during the January 26th meeting the Hillside Overlay Zone and the land parcels under consideration for the zone. They designated two areas, the East Bench and the Summit Ridge Area. Areas of the East Bench that currently are not in the City have been designated for this overlay zone as well. A public hearing is scheduled for February 9th and recommendation will be made to the Council after that meeting.

Also discussed were changes to the bi-laws concerning the electronic attendance at the meetings. The language will be forwarded to the Mayor and Council for consideration.

NEW BUSINESS

Discussion and possible action with regard to Baseball and Softball Uniforms

Director Schmidt and Ms. Johnson address the Mayor and Council Members with regard to the ability to increase and improve the recreation programs. They have been working diligently on increasing Recreation programs within the city.

Comparisons with other Cities show Santaquin Recreation is charging the average fee. Santaquin City does not currently offer a Coaching Incentive Program. Director Schmidt will continue to researching the prospects of this offer and share the information with the Mayor and Council Members when it is available. (See attachment "A" for the presentation).

Council Member Steele was told the Recreation Department doesn't preorder uniforms which eliminates waste. This is the reason the uniforms are not ready until just before the 1st game. Each Child would keep the uniform shirts.

A sample of the shirts available was shown to those in attendance. It was noted that the pricing is included in the presentation printout.

Council Member Carr was told requesting a partnering with local businesses to offset the cost of uniforms were discouraged in the past due to the request for support for the Celebration.

A survey was taken by the Recreation Department. Approximately 70 of 300 surveyed completed the survey which showed the parents were about equal on having nicer uniforms compared to raising costs for the event. Ms. Johnson reported "dressing the part helps the players act the part".

Director Schmidt thanked the Mayor and Council Members for the increase in the Recreation Budget. He indicated the money will be well spent replacing the fridge and purchasing a freezer.

Council Member Steele moved to "go with the nicer uniform" the button wicking fabric. Council Member Carr seconded the motion. Council Member Broadhead asked and was told they should be able to make the purchases with the current budget. After the discussion, the vote was unanimous.

Discussion and possible action with regard to Mud Races

The Council Members were supportive of the Staff researching the logistics of the proposed event. Council Member Carr moved to authorize staff research the logistics and complete a cost analyze for the mud races. Council Member Steele seconded the motion. Council Members Broadhead, Carr, Payne, and Steele voted in the unanimous.

Discussion and possible action with regard to section of Capital Projects utilizing Park Impact Fees

Direct Marker reported the believed this discussion is to formalize the projects discussed in the work session this past week the projects discussed was additional development of the North Park, adding a sidewalk to the Main Street Park, and enhancing the Orchard Lane Park. He has met with the Public Works Director Eva and Supervisor Callaway to discuss the proposed projects. They requested additional enhancements added to the Orchard Lane Park so they can get their mowers in and out of the park. This would include adding a curb ramp into the park with additional sidewalk from the existing sidewalk to the bowery.

Director Marker indicated J-U-B Engineering Representative Mark Christensen met with them to discuss what engineering can be handled within the Community Development Office and what coordination needs to help save costs. The practice of engineering is regulated by the State. There are very strict laws as to what can be completed without an Engineering License. Staff Planner Flint can complete the layout as to where lines would need to be installed. He isn't allowed to complete any survey work or grading designs.

Council Member Broadhead asked if the project is a "not to exceed the \$300,000". "Can you do it for that"?

Council Member Steele asked if the funds could be used on a 4-plex. He was told at this time the only thing that could be completed on a 4-plex is the design. It is anticipated that the Council wouldn't want to spend money on a design when the Capital Facilities Plan shows the only 4-plex being located in the spot of the rodeo arena. Staff Planner Flint has looked at laying out a 4-plex on the 35 acres at Summit Ridge, at the rodeo grounds and placing it up on the East Bench. A lot of the conceptual design can be handled in house without expending any Engineering costs but impact fees themselves cannot pay Staff wages.

Council Member Carr would like to have the Staff spend more time researching a ball complex, how many acres to build it, is there other land. He thinks it would be prudent to complete the

research before a final decision is made. The Mayor and Council were reminded that the Capital Facilities Plan is showing a 4-plex being constructed at the current rodeo grounds. The costs estimates on a 4-plex could be ready by next week. Changing of the facilities plan could take as little as a month. He was told the critical "cut-off time" for any project. Director Marker indicted the Main Street and the Orchard Lane Park projects could be completed within as little as 2 months. Because of the Engineering requirements of the Orchard Cove Park a final decision needs to be made within the next 2 weeks.

Council Member Broadhead was told the monies had to be spent by June 31 not just allocated. Council Member Broadhead said "so you can do a design/build type thing on the park, you can spend it pretty quick". Director Marker indicated "Cities are not authorized to do design/build projects unless the project will exceed \$10,000,000". Council Member Broadhead said "you sure see a lot of them going it without that is less than \$10,000,000". "If we can amend the plan, within a month, and move these fields to Summit Ridge, then you can spend the \$210,000 on design by July". He was told it would depend on if the current City Engineer was used or if the engineering was put out to bid. It would take time to request and receive engineering bids. Director Marker commented that an Architectural Design Firm may be able to design the project. Council Member Broadhead said you could have design and pre pay if you know what it is going to cost.

Council Member Steele moved to table the decision until we get further information. Council Member Carr seconded the motion. Council Members Broadhead, Carr, Payne, and Steele voted in the unanimous.

INTRODUCTIONS AND ADOPTION OF ORDINANCES AND RESOLUTIONS

Resolution 02-01-2012 "A Resolution authorizing adjustments to the FY2011-2012 budget"

Council Member Carr moved to approve Resolution 02-01-2012 "A Resolution authorizing adjustments to the FY2011-2012 Budget". Council Member Steele seconded the motion. Council Members Broadhead, Carr, Payne and Steele voted in the unanimous through a roll call vote.

Resolution 02-02-2012 "A Resolution pertaining to the cooperative agreement with Qwest Corporation, dba Century Link QC"

Quest hired a sub to install conduit throughout the City's right-a-way. The surface workmanship was very poor. Quest has acknowledged the poor workmanship at the same time are requesting utility easements from Orchard Lane down 400 East to 400 North to 200 East to the Strawberry Canal. The proposed contract would allow 120 days to improve the poor workmanship. If the contractors do not complete the improvements they are responsible to pay the city to complete the repairs.

Council Member Payne commented that there should be no pedestals installed in the middle of the trail. They are planned for the right-of-way not within the trail way.

Council Member Broadhead was told a permit was granted but a bond was not required.

Council Member Payne moved to approve Resolution 02-02-2012 "A Resolution pertaining to the cooperative agreement with Qwest Corporation, dba Century Link QC". Council Member Broadhead seconded the motion. Council Members Broadhead, Carr, Payne and Steele voted in the unanimous through a roll call vote.

Resolution 02-03-2012 "A Resolution authorizing an Employment Agreement Renewal for the position of City Manager"

Council Member Carr suggested clarifying the wording in Paragraph 12 "being removed for cause" by adding "as defined in Section 4.5b of the Santaquin city Employee Policy and Procedures Handbook".

Council Member Payne requested the word change in Paragraph 6b word "consolation" to "consultation".

Council Member Broadhead reported he had reviewed the City Manager contracts of other cities. He commented that the proposed term of the contract is 3 years which will be binding other Mayor and Councils. He requested the contract terms be reviewed by the City Council yearly. In Paragraph 5 it reads "on favorable performance reviews of Reeves by the City" he would like the review to include the Council Members. He questioned who reviewed the expense reimbursements. He was told they are reviewed by the Mayor before they are approved by the City Council. In Paragraph 8 "Covenant Not to Disclose Confidential or Proprietary Information" means the items discussed would be turned over to the Mayor. Paragraph 11 "Termination" would require a super majority vote which is 4 out of 6 Council Members with the Mayor having a vote. A request of clarification within Paragraph 11d, the severance would be paid if separation is "not for cause". In paragraph 12 a reference to severance pay equaling 6 months of employment is made. Other cities offer 3 months plus 2 weeks additional per year of employment severance. In his opinion it should be 3 months.

Council Member Carr commented the severance is 6's either way.

Council Member Carr moved to approve Resolution 02-03-2012, A Resolution authorizing an Employment Agreement Renewal for the position of City Manager with the addition of Paragraph 12 referring to the City's Personnel Policy. Council Member Payne seconded the motion. Through a roll call vote, the vote was as follows:

Resolution 02-03-2012 passed with 3 to 1 vote in favor of the Resolution. Council Member Broadhead added, "it's nothing personal".

Ordinance 02-01-2012 "A Temporary Ordinance Modifying Animal Rights for Educational Purposes."

Council Member Broadhead indicated he would like to hear the comments of the neighbors after being notified by the applicant wanted to utilize the temporary ordinance.

Council Member Payne moved to approve Ordinance 02-01-2012 "A Temporary Ordinance Modifying Animal Rights for Educational Purposes with direction to City Staff to work with the Planning Commission to review the current Ordinance and amend the ordinance to have the petitioners report to the City Staff on the notification of the neighbors". During the discussion the question was asked if a permit would be needed. Council Member Broadhead seconded the motion.


