## MINUTES OF A COUNCIL WORK SESSION HELD IN THE COUNCIL CHAMBERS MAY 4, 2011

The meeting was called to order by Mayor Pro Tem Filip Askerlund at 6:02 pm. Council Members attending: Martin Green, Rick Steele, and Brent Vincent. Mayor James DeGraffenried and Council Member Jim Linford were excused.

Others attending: City Manager Ben Reeves, Community Development Director Dennis Marker and Director of Public Safety Dennis Howard.

#### **DISCUSSION ITEMS**

Mayor Pro Tem Askerlund reported the Contractor has begun the work within the area behind the right-of-way. There will be another change order for I-15 to 400 East for the additional lane. The Council Members didn't have any issues with approving the change orders as long as they do not exceed in the approved project budget.

Council Member Vincent was told the project would include underground utilities and planter boxes. The approaches will be constructed to the new grade.

# Temporary signage allowances along Main Street during the construction project

Director Marker presented the Council Members with an Ordinance addressing Temporary signage which can be in place during the Main Street Project. The proposed ordinance will be on the next Council Meeting Agenda for approval.

### Fire Suppression requirements in the Agricultural Zone
