Santaquin Seasons Request to Pay Money in Lieu of Providing Water

Mr. Richard Porter, who is the developer of the Seasons of Santaquin Assisted Living Center, has requested the Santaquin City Council authorize him to pay money in lieu of providing water for his development, the Santaquin Seasons Subdivision. The subject property was annexed into the City with the Oak Summit Development, and no water dedications have been provided for it.

Santaquin City Code, §8-1-12(B) Annexations, states, "Acceptance Of Cash Equivalent Of Water Rights: The city may, at its discretion, accept the cash equivalent in value of the cost of water rights and/or shares required to be dedicated. The equivalent consideration will be based upon the most recent information of similar water sales available to the city. The number of water rights, shares or the amount of the cash equivalent shall be determined by the expected water needs of the annexation area based in part on the total number of acres located within the annexation area and the portion owned by the person making application."

Santaquin City Code, §8-1-12(A) requires a dedication of 3 acre feet of water per acre being developed. The Santaquin Seasons Subdivision Plat includes 1.919 acres. This necessitates 5.757 acre feet of water be dedicated to the City. Mr. Ken Tuttle, who works for Sunrise Engineering and is the City contracted water engineer, has stated that within the Santaquin area, water currently costs approximately \$3,200 per acre foot. The City Council could authorize the payment of \$18,422.40 in lieu of having water dedicated to the City.

The subject plat has been forwarded to the Planning Commission for final plat approval. The plats can not be recorded until full dedication of water or payment in lieu thereof is provided as well as bonds being placed with the City.
