Awarding of Bid to Relocate Commercial Signage Affected by Main Street Widening Project

Mayor DeGraffenried

City Manager Reeves reported the Staff is busy working on the Wastewater Reclamation Facility issue as well as the Main Street Project. Both projects have anticipated ground breaking for April.

He also reported it is budget season and the department heads will have input throughout the process.

City Manager Reeves was told Mayor DeGraffenried and Council Members Linford and Vincent would be attending the Chamber dinner on February 22 with their partners.

City Manager Reeves reported the results of the UDOT Speed Limit Study US-6 (Main Street) from West City Limits to 200 East is complete. The purpose of the study was to determine if the location of the 35/60 MPH speed limit change point near the UDOT maintenance station was appropriate based on typical driving conditions. The speed limits will be decreased from 60 to 50 about ½ mile east of current point then to 35 about ¼ mile of the current change point. See attachment E for report.

Council Members

Council Member Linford said he would be attending the SUVWA meeting in the morning and would be discussing water drainage into Utah Lake as well as a ground water recharge project. Council Member Linford will report on the discussion at a later date.

Council Member Green requested Director Howard pass his appreciation on to the Fire Department for their help with the West Mountain house fire.

Mayor DeGraffenried requested names of individuals who would be willing to serve on the Celebration committee. The Council Members agreed to supply the names to the Mayor as quickly as possible.

Mayor DeGraffenried also reported he and various department heads are working with the County to address snow melt and run off. Additional information will be provided as it is available.

Thank you for your desire to join us in the list of responsible people that are standing up for the First Amendment of the Bill of Rights.

An Oklevueha Native American Church Authorized Participant Card is not necessarily a membership card, for what other religion has a card to prove they are a member of a particular faith? In the same vain of thought, what church has a federal exemption to utilize controlled substances for their Sacrament? NONE - However, three higher courts unanimous decisions of the United States, including the U.S. Supreme Court, make it very clear and concise that any and all government agencies of the United States have 'no legal authority' to influence any church with it's ideology (by-laws) or limit the participation of a churches religious practices based on race (American Native) or political affiliation (Federally Recognized Tribes) or deny access to American Native Indigenous Sacred Ceremonial grounds. As a matter of law, the United States governments are to protect these constitutional rights. These unanimous rulings state very clearly that all members of 'any' *federally recognized tribe* and/or 'members' of a bona fide *Native American Church* have the constitutional rights and protection to worship with any and all earth based Sacraments 'especially Peyote'.

With this understanding, should a Tribal Member be stopped on the highway while possessing a Native American Church Sacrament, he or she can submit to the law enforcement officer their tribal card (which entails decades of sacrifices). Now if an Oklevueha Native American Church Authorized Participant Card holder (Who is not a Federally Recognized Tribal member) finds him or herself in the same circumstance, they can now prove their legitimacy to have a Native American Church Sacrament in their possession. (\$100.00 is a relatively insignificant sacrifice compared to what Federally Recognized Tribal American Native People have endured to enable you, and all other races to benefit from their Sacrifices to worship their indigenous cultural practices).

Also, your \$100.00 will be contributing to the advancement of Oklevueha Native American Church (ONAC) Habilitative Programs and ONAC defense legal fund.

§ 1996. Protection and preservation of traditional religions of Native Americans

How current is this?

On and after August 11, 1978, it shall be the policy of the United States to protect and preserve for American Indians their inherent right of freedom to believe, express, and exercise the traditional religions of the American Indian, Eskimo, Aleut, and Native Hawaiians, including but not limited to access to sites, use and possession of sacred objects, and the freedom to worship through ceremonials and traditional rites.

United States Prosecutors REFUSED TO PROSECUTE this case and United States District Court Judge accepted the States request to dismiss.

Why the United States and the State of Utah Courts refuse to prosecute Cannabis Cases involving Oklevueha Native American Church Authorized Participant Card holders

Tuscarora Indians of the Tuscarora Indian Reservation, in Lewiston, NY, near Niagara Falls part of North Carolina Tuscarora people of the Iroquois Confederacy established in 1570, The name Tuscarora means care taker of Cannabis Sativa.

It is unquestionably understood that the Northwest Mexico Tepecano Indians and Indians in the Mexican states of Veracruz Hidaigo, and Puebla practice a communal curing ceremony with a plant called Santa Rosa, identified as Cannabis Sativa (Controlled Substance), which is considered both a plant and a sacred intercessor with the Virgin. Although the ceremony is based mainly on Christian elements, the plant is worshiped as an earth deity and thought to be alive and to represent a part of the heart of God.

The Tepehua, another Mexican Indian group also use it under the name of Santa Rosa (Controlled Substance) in healing ceremonies, considering it to act as an intercessor with the Virgin and the Tepecano, of northwestern Mexico occasionally use it as a substitute for Peyote in their rituals calling it Rosa Maria (Controlled Substance).

CHAPTER II - DRUG ENFORCEMENT ADMINISTRATION, DEPARTMENT OF JUSTICE

PART 1307 - MISCELLANEOUS

1307.31 - Native American Church (NAC).

The listing of peyote as a controlled substance in Schedule I, does not apply to the non drug use of peyote (Controlled Substance) in bona fide religious ceremonies of the Native American Church, and members of the Native American Church so using peyote (Controlled Substance) are exempt from registration. Any person who manufactures peyote for or distributes peyote (Controlled Substance) to the Native American Church, however, is required to obtain registration annually and to comply with all other requirements of law.



As of this date, Mr. Tucker has not made contact with us and the bucket is still located on our property and Alexander's towing has not been compensated.

My request at this time is to declare this bucket abandoned and surplus property. I wish to release the bucket to Alexander's towing in order to clear the \$145 tow bill.

This is in accordance with Santaquin cities police policies and procedures on release of property under section 4. Utilization of surplus or destruction of property.

Enclosed in your packet is an asset disposal request from Chief Dennis Howard to surplus an Excavation Bucket that is currently impounded. While I support the Chief's request to have this item surplused and recommend such action to you, I respectfully request that the council follow both state law and your normal disposal procedures by having this asset disposed through a public bid or auction rather than giving it away to retire a towing bill.

It is my undering that the value of this Excavation Bucket is roughly between \$3,000-\$5,000 new and should generate a minimum of \$2,000 in its used condition. I understand Dennis' desire to maintain a good working relationship with the individual to whom he wishes to donate this item, however, during these tough economic times every dollar counts more than ever. Furthermore, following existing procedures not only complies with Utah State and Santaquin City's laws and ordinances, such actions are also consistent with safeguarding the public's trust as stewards of the taxpayer's resources.

US-6 (Main Street) from West City Limits to 200 East, Santaquin**

Dear Mr. Chatwin,

During 2010 our Traffic and Safety Division conducted a speed limit study on a section of US-6 which included a segment from the west city limits to 200 East. The purpose of the study was to determine if the location of the 35/60 MPH speed limit change point near the UDOT maintenance station was appropriate based on typical driving conditions.

The results of the study suggest the speed limit could be decreased from 60 MPH to 50 MPH about one-half mile west of the current change point, and then change to 35 MPH about one-quarter mile east of the current change point. This new change point would still be about one-quarter mile west of 400 West and not impact the school crosswalk area. Attached is a copy of the pertinent study results including a speed profile graph depicting this information.

The Division recommends the speed limits be changed as described, and this office agrees with the Division. The recommended changes are based on sound traffic engineering principles and on several factors considered along with the 85th percentile speed. These factors are road characteristics, roadside culture, safe speeds for curves, pedestrian activity, and crash history.

This letter notifies the City that we intend to move forward with these changes. If the City would like to comment on these planned changes, it may do so in writing by letter or e-mail to Shane Marshall, our Region Director by February 25. The Division of Traffic & Safety has conducted a speed study at the subject location as requested. Based on the study results, we recommend changing the posted speed limit as noted on the speed profile.

As part of our study analysis, the following factors were considered along with the 85th percentile speed:

- Road characteristics including shoulder condition, grade, alignment, and sight distance.
- Roadside culture and development, and roadside friction.
- Safe speeds for curves.
- Pedestrian activity, parking practices, and other traffic.
- Reported crash rate of 1.304 for the most recent 3-year period. This crash rate is considered low in comparison to the average crash rate at 6.79 for the same classification – Urban Minor Arterial.
