### Mayor DeGraffenried

Mayor DeGraffenried indicated promises were made to the residents of the Northeast Annexation that they would have a "say" in what is allowed within the newly annexed area. City Planner Marker reported the general feel of the property owners within that area is that the property continues to have a rural feel. Council Member Askerlund indicated he liked the concept of this kind of building and would like residents of the annexed area to be included in the planning of such a development.

City Planner Marker indicated Payson City is reviewing their Master Plan to include high density around the area of the proposed LDS Temple. Mayor DeGraffenried requested City Planner Marker keep the Council Members appraised of any discussion with regard to the development. He also requested residents of the area be included.

### Council Members

Council Member Askerlund reported the City hasn't received the 35 acres that was required from Summit Ridge. Mayor DeGraffenried reported the reason the property has not been deeded to the City is because the City has 10 years from the date of deeding to use the property. If the City does not develop the property within the 10 year time frame, the developer has the option to purchase the property at \$1,000 per acre. Legal Counsel Rich will review the original agreement.

Council Member Askerlund reported the Website Committee would have a booth at the park during the celebration to allow the residents to vote on one of four different logos.

Council Member Steele was told the Main Street curb painting probably would not be completed before the Celebration but the cleaning of Main Street will be completed.

Council Member Steele reported he somewhat appalled by the e-mail he received from a resident "chewing out the Council for not allowing the Red Barn to advertise in the Celebration Ad booklet". Council Member Askerlund reported EVERY attempt is made to include EVERY business in the information booklet. Mayor DeGraffenried reported the Rowley's did not have anything to do with the e-mail that was sent. The e-mail was not sent on behalf of the Rowley's. The Cherry Pit Spit will be held on July 31<sup>st</sup> with an invitation being issued to the Mayor and Council to attend and participate. City Manager Reeves has responded to the e-mail with the Mayor and Council Members being sent a copy.

Council Member Vincent indicated in the near future he would like to discuss the speed limit along Highland Drive. City Manager Reeves will add this issue to a future agenda.

Council Member Vincent requested the Mayor and Council Members be told when the City is represented by a sports team at any state function.
