# INTRODUCTIONS AND ADOPTION OF ORDINANCES AND RESOLUTIONS (Roll Call Vote) Resolution 06-01-2009 "A Resolution Establishing the Fee Schedule for Santaguin City"

A discussion was held as to what the Parks and Recreation Impact Fee should be. Council Member Askerlund reported he is having difficulty adopting the maximum Parks and Recreation Impact Fee. He was told the current impact fee analysis does not include the Summit Ridge area. The new analysis does include this area. It was clarified that the impact fees collected from the building in that area cannot be used to complete a park within the "Summit Ridge" area. The Mayor and Council Members were told grants are continually being researched. It was reported that the "pot" of Park Impact Fees will be what builds the requested parks. Council Member Green indicated he isn't in favor of implementing the maximum fee. It was reported that the average impact fee is \$3800. Santaquin is currently is about 50% of the average. Removing the high and low assessed fees would bring the average to approximately \$3600. It was also reported that every 5 years the State requires all Impact Fees be re-analyzed. Council Member Vincent was told the impact fees can be used for purchase of ground as well as development of parks. Council

Member Askerlund asked if the City is required to purchase land what would the balance be in the impact fee fund. The exact amount was not available at this time. The maximum allowable by the study would be \$3,362.90. Council Member Hansen indicated she is willing to support \$2500 with the fee to be reviewed in approximately 2 years. It was suggested to Council Member Askerlund to set a fee amount and not attach a maximum review timeline to the approval. He indicated he thought it would be wise to review the issue as needed.

Council Member Askerlund moved to approve Resolution 06-01-2009 "A Resolution Establishing the Fee Schedule for Santaquin City" with the Wastewater Impact Fee of \$6,500 and the Parks, Trails and Open Space Impact Fee at \$2,500. Council Member Vincent seconded the motion. Per roll call vote, Council Members Askerlund, Green, Hansen, Linford and Vincent voted in the unanimous.

# REPORTS BY MAYOR AND COUNCIL MEMBERS Mayor DeGraffenried

Mayor DeGraffenried reviewed a proposed "Letter of Support" pertaining to the Nebo School Bond Issue. Council Member Askerlund was told an existing bond would be extended to incorporate the proposed increase of the bond amount. He was told that by not signing the "Letter of Support", Santaquin would not have any repercussions. When the Mayor met with the School District Representatives he was told there aren't any schools planned within the 5 year plan, for the Santaquin Area. The Council Members were in favor of the Mayor signing a "Letter of Support" although not all Council Members are in favor of the issue as a whole and would not be voting to support the bond.

#### **Council Members**

Council Member Hansen reported she as well as Council Member Askerlund met with the Representatives of Maverick. They are planning to open the doors on July 14. They will be holding a B-B-Q during the Celebration. Also the grand opening will be held on August 21st.

She also reported the Chamber of Commerce will be holding their Summer Party on June 30<sup>th</sup> at the Squashhead Park.

Council Member Hansen was told there are currently 4 non-premises consumption liquor permits as well as 1 in the review process.

She was also told the Interlocal Agreement with Nebo School District has been returned to their Representatives for review of the "City's" comments.

City Planner Marker reported he is in the process of soliciting design concepts for a park at Summit Ridge.

Council Member Linford reported the Utah Transportation is holding an update meeting on June 24 in Payson. City Planner Marker will also be attending.

Council Member Askerlund requested a review of the Engineering Services Contract.

He reported Ogden has a Retail Advisory Committee which has posted a \$20,000 cash prize (1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>) for anyone who brought to them the best overall business plan.

Council Member Askerlund was told Representatives of UTA have been contacted with regard to their services within the City. The City Representatives have been told we would be required to join the Transportation District before UTA would extent their services to Santaquin. At this time, County Representatives are working on this issue. Council Member Askerlund requested the Mayor address this issue in his Mayor's Memo.

Council Member Askerlund reported on June 27 a group of individuals would be "cleaning up" and "getting ready to use" the ball field at the Santaquin Elementary School. He requested support of the Council Members and the Recreation Director. The project will begin at 7 am and should take about 2 hours to complete.

Council Member Askerlund asked if the Council Members would like to revisit the Main Street Overlay Ordinance. Council Member Hansen indicated she has received a number of positive comments with regard to the construction on Main Street.

Council Member Askerlund reported the last week has been phenomenal with regard to Celebration donations. Approximately \$5000 was collected which includes an additional donation from Subway as well as an additional donation from J.E. DeGraffenried Construction. It was reported the Celebration tee shirts have been ordered. Council Member Askerlund expressed his thanks to all who have helped with the Celebration efforts.

Council Member Askerlund was told the issue of grocery store has not "died". City Representatives are in continual contact with Representatives of the "grocery store" developers.

Council Member Askerlund reported the City Employees are working on the new Announcers Stand at the Arena. Grant money will pay for the majority of the project.

Council Member Green reported he has received numerous requests to draft a Noise Ordinance. City Planner Marker has this issue on his list of things to do.

Council Member Green questioned what the Council Members would like to ride in for the parade this year. Mayor DeGraffenried offered to request his brother bring his team of horses and wagon.

At 9:35 pm Council Member Linford moved to adjourn. Council Member Askerlund seconded the motion. Council Members Askerlund, Green, Hansen, Linford and Vincent voted in the unanimous.
