### FORUM, BID OPENINGS, AWARDS, AND APPOINTMENTS

Mr. Roberts, President of C.S. Lewis Academy, thanked the Mayor and Council for their help with getting the roadway reopened during the Main Street and SR198 realignment project. He indicated the parents were very pleased with being allowed to have a direct route to the school.

Mr. Roberts also reported the school made a decision to install all the landscaping instead of installing the trail, as indicated in the site plan, along Highland Drive. Council Member Askerlund was told C.S. Lewis Academy should have a contract with the City addressing the time frame associated with the trail installation. Council Member Hansen was told the Trails Master Plan addresses the connection of the City to other Cities/Towns through a trails system. Mayor DeGraffenried thanked Mr. Roberts for attending the meeting this evening.

Mrs. Durney addressed the Mayor and Council Members with regard to the need for a Noise Ordinance (see attachment "A"). She provided the Mayor and Council Members, Legal Counsel, City Recorder, and City Planner with a copy of Payson's Noise Ordinance. Mr. Killpack requested an update with regard to the UTA Bus service within the Santaquin City area. Mayor DeGraffenried indicated the City is currently working with UTA and Commuter Rail to expand service to this area. Mr. Killpack was told the County Commissioners have been discussing a time frame associated with the expansion but have not set a definite date.

### REPORTS BY MAYOR AND COUNCIL MEMBERS

City Planner Marker reported that the Sumsion family who owns property included in the Northeast Annexation has a concern as to what could be done with the existing pit. The current County permit allows excavation and hauling only. The County allows a 1 to 1.5 slope with regard to reclamation issues. The property owners would like to begin the reclamation efforts in the manner that would benefit the future use of the "pit" property. It was reported the property owner would like to complete the current allowances within the County permit. The completion time frame associated with the permit is approximately 10 years. Council Member Askerlund indicated the pro's are that the City would have control of excavation and reclamation and a revenue base. The property owners would like to add a crusher to the property. Currently the City has a mass grading Ordinance that the property owners are required to adhere too. Council Member Green indicated he would like to think about this issue for "a while".

### Mayor DeGraffenried

Mayor DeGraffenried reported he would be meeting with J-U-B Representative for an update on the PI Project finances, the Police Inter-local Agreement as well as the School District Agreement will be in their boxes by next Wednesday. Mayor also reported the construction has begun on the Pole Canyon road and the Sorenson's have signed with Boyer for the property purchase.

Mayor DeGraffenried also reviewed the cost of funding Years of Service Awards as well as cash Christmas gifts (see attachment "C"). The Council Members were in agreement with the cash proposals.

A discussion was held with regard to possibly purchasing rights within the East Santaquin Irrigation Company. Additional discussions will be held in the near future.

Dear Mayor and Councilmen:

I appreciate being able to address you tonight concerning a problem that is becoming increasingly more complex in Santaquin as the city matures. It is the definite need for a noise ordinance.

Five or six years ago I came to City Hall and inquired of three or four different workers as to whether the city had a noise ordinance. I was told we did have but no one knew where to find it, so I was given the number of the dispatcher to call as needed.

As we live in a full-fledged city and we talk the talk of city, I believe we need to walk the walk; to get in place some meaningful statements regarding Public Peace and Safety. We need a comprehensive and enforceable noise ordinance.

I decided to research what cities around us are doing about the problem. Genola has a noise ordinance that is now being reviewed. I was mailed a copy of Salem's ordinance that is good, but they don't have to contend with I-15 going through the middle of their city, so it is not comprehensive enough. A clerk in Nephi said, "Yes, we have an ordinance. I'll fax you a copy as soon as I finish what I'm working on." She called later and told me they have no ordinance; a big surprise!

A worker in the Payson City Mayor's office referred me to their website where their noise control ordinance is listed. It comes under Title 7 Public Peace and Safety. It was like finding the holy grail to know city fathers cared enough about their citizens to adopt it on November 19, 2003. I have made copies for each of you, for the City Recorder and for the City Attorney and respectfully ask you, in good faith, to develop a similar ordinance for Santaquin. It is comprehensive and includes problem like ATVs, jake brakes, etc.

I read with interest, Mayor, your memo about getting a hotel and Maverick Store on the east bench. I thought of all the times we traveled and would have been blessed to stay overnight in as peaceful and beautiful a place as Santaquin, and know that you will go all out to make it a peaceful and inviting place to stay. I'm hoping the same peace can consistently be available to all citizens.

RE: Requested extension of Stone Hollow Plats C, D, & E approval

According to Santaquin City Code (S.C.C.), 11-5-7 & 8, final plat approvals are good for one year and preliminary approvals are good for two years. Stone Hollow Plat C was granted final approval on June 20, 2007. Stone Hollow Plats D & E were granted preliminary approvals on December 6, 2008. Neither of these subdivisions has been recorded to date. Mr. Troy Kunz, representing Summit Ridge Communities, LLC has requested the City Council grant an extension of the above approvals.

The S.C.C. does allow the City Council to extend approvals for final plats a maximum of 6 months. Plat C was already given one final approval extension on June 4, 2008 and would lapse on December 4, 2008.

The S.C.C. allows the City Council to extend approvals for preliminary plats a maximum of 1 year. The preliminary approval of Plats D & E would lapse on December 6, 2008 if not extended.

The applicant is requesting these extensions due to current economic conditions.

Staff recommends the City Council grant the 6 month final approval extension for Stone Hollow Plat C and the 1 year preliminary approval for Stone Hollow Plats D & E.


