REPORTS BY MAYOR AND COUNCIL MEMBERS

Council Member Vincent reported he had a resident inquire about junk cars being kept on their property. He was told to submit the information to the Police Department and they will handle the enforcement from there. Those in attendance were told the property owner in question has been served with a notice to clean up the property. Director of Public Safety Howard indicated the process is very lengthy. The Mayor requested he submit ordinance change recommendations to the City Planner.

Council Member Linford submitted two names of individuals who may be willing to serve on the Appeals Authority Board. Others were asked to submit names also.

Council Member Linford suggested having the City represented at the Utah Lake Commission Open House. He recommended having a City booth and possible give out apples. He believes the Council Members should attend as well as some of the staff members.

Council Member Linford was told the 3rd phase of the Pressurized Irrigation project is the pond with the Eastside phase being the 4th phase.

Council Member Linford indicated he has driven around the City and has a concern with how the city is being maintained in many areas.

Council Member Askerlund was told the information letter with regard to the City Wide Cleanup has been dispersed throughout the City. Council Member Vincent volunteered the Chamber of Commerce's grill to use for grilling hotdogs. Council Members Vincent and Linford volunteered to help with the cooking.

Council Member Askerlund reported two members of the former roping club removed panels from the arena. The individuals then told a City Representative that they had removed them. Mayor DeGraffenried reported he had spoken with Brandon Wall and requested he get the panels returned. Mr. Wall indicated they had receipts showing the roping club had purchased the panels. Mayor DeGraffenried told Mr. Wall he needed to get them back today or tomorrow.

Council Member Askerlund voiced his concern with regard to the Mayor and Council Members taking their fiduciary responsibility very seriously. He would like to have rules and regulations drafted for the use of City Credit Cards. Mayor DeGraffenried will work with the staff to draft such rules. Council Member Green would like to have included on the receipt the purpose of the purchase.

Council Member Adcock was told Mayor DeGraffenried will request an Engineers update on the Pressurized Irrigation project and report during the next work session.

Council Member Adcock was told there wasn't any new information with regard to a business license for Oberg Storage Sheds.

Council Member Adcock was told Recreation Manager Schmidt has taken under advisement the possibility of moving the soccer goals which is located behind the City Office.

Council Member Adcock reported Judge Williams had surgery this morning. She may be out of commission for a short period of time.

Mayor DeGraffenried reported the relocation of the Court should be completed within the next 4 weeks.
