#### **NEW BUSINESS**

Discussion and possible action with regard to additional office help

Mayor Scovill reviewed with the Council Members the need for additional office help. Mayor Scovill indicated he has concerns with regard to the tasks associated with the office personnel. With the growth of the City he has a concern with the Treasurer handling the Treasurer responsibilities while the Recorder handles the Recorder responsibilities.
