### City Engineer

City Engineer Fullmer reported that the pump for the Cemetery Well arrived but while installing the pump the pump was dropped and lodged in the well casing. The Representative of Utah Pump claimed there were issues of sabotage associated with the pump being dropped. As of this date the pump has not been retrieved. Until it is retrieved the amount of damage cannot be assessed. City Engineer Fullmer reported that Employees of Utah Pump has been trying to fish the pump out of the well for the past two days. It was suggested to set a time frame in association with the well being up and running. If this time frame is not met monetary damages will be assessed.

City Engineer Fullmer also reported the road project is progressing. The curb and gutter in front of the City Office will be replaced at the time the road is repaved.

The Library curb and gutter will be completed with in the next two days. This will be completed before the new road is completed and the parking lot is asphalted.

City Engineer Fullmer reported that additional information has been submitted to the State with regard to the Sewer Project. The State received a letter of concern with regard to the proposed project from surrounding property owners. The property owners received a follow up letter from the State indicating there is a permitting process that is required and the City is following this procedure. The property owners submitted to the City, an Engineering study preformed by an Engineering Firm of their choice. Epic Engineering, who preformed the Sewer Study, for the City, has received a copy of the independent firm's study. Epic Engineering will address the issues and send a copy of the finding to the City.

City Engineer Fullmer reviewed with the Mayor and Council members a proposed design to place a parallel sewer line along 730 North. Developer Caines has indicated he would be responsible for re-asphalting of the road during the construction of the Alpine View Subdivision Plats "B" and "C". (See attachment "A" for the Preliminary Engineers Estimate associated with the project) A final decision will be made at the next Council Meeting.
