MINUTES OF A REGULAR COUNCIL MEETING HELD IN THE COUNCIL CHAMBERS OCTOBER 5, 1999

The meeting was called to order by Mayor Keith Broadhead at 7:00 P.M. Council members present: Kirk Greenhalgh, LaDue Scovill, Lynn Adams, and Frank Staheli.

PLEDGE OF ALLEGIANCE

PUBLIC HEARINGS

Council member Adams moved to open a Public Hearing with regard to proposed amendments to the Zoning Ordinance. Council member Staheli seconded the motion with an unanimous vote.

City Planner Jackson reviewed the proposed amendments to the Zoning Ordinance with those in attendance. Commission Chairperson Askerlund indicated the Planning Commission has held the required Public Hearing at that level.

Brent Vincent questioned why the particular requirements are attached to the Overlay Twin Homes section of the proposed Ordinance. He indicated he thought the requirements were unfair.

Mayor Broadhead reported the Council will discuss the issue at a Mayor and Council Work Session to be held on October 13, 1999.

Byron Bastian reported if a home was required to have 900 square foot of living area and a 2 car garage, the building lots are currently to small in the Eastside Subdivision.

Mr. Vincent indicated there is a requirement, in the proposed Ordinance, that regulates landscaping but does not have a completion time frame attached.

Judy Vincent questioned if a person has a vacant lot next to their home, is the lot considered a side yard and would be required to meet the landscaping requirements? She was told the owner of the property should keep it clean and cleared.

James Demita, Developer of the Eastside Subdivision, indicated he was in favor of having

Also reported was that a Valley Asphalt Representative has made application to County for expansion of the use of the proposed annexation property. No further details are available.

City Manager Austin reported five applicants were interviewed for the Billings Clerk Position. Shannon Hoffman was offered the Position with Sherron Davis accepting a position in the City Manager and City Inspector's office.
