## MINUTES OF A SPECIAL COUNCIL MEETING HELD AUGUST 11, 1992 IN THE CITY CENTER

The meeting was called to order by Mayor D. Lynn Crook at 6PM. Councilmembers present: Keith Broadhead, Max Holman, Hortt Carter and David Hathaway. Gerald Fowkes was ill and excused. Also present was the Water Superintendent, Dennis Barnes.

Keith and Dennis reported on the status of the water supply.

Options to conserve water were discussed.

Keith moved Proclamation 92-1, restricting outdoor water use, be approved, Max seconded, passed 4-0. (attached)

It was agreed City workers would pass a copy of this Proclamation door to door.

Council discussed the Surplus Sale scheduled for Saturday morning. Items for sale include a backhoe, tractor, three guns, 2 scooters, several bikes and a freezer which it was agreed the Fire Department and EMTs could purchase from the Senior Citizens. Council agreed to accept all bids. high

At 7PM Max moved the meeting be adjourned, Hortt seconded, passed 4-0.

## PROCLAMATION 92-

- WHEREAS, The State of Utah and the City of Santaquin are in a drought period, and
- WHEREAS, The summer day time temperatures are above ninety degrees, and
- WHEREAS, The City springs in the Santaquin canyon are running at 80% of capacity, and
- WHEREAS, The water demand is greater than the supply, and
- WHEREAS, The new springs & new well will not be complete untill . September 20th, 1992, and
- WHEREAS, The City must maintain a minimum of 180,000 gallons storage at all times for fire protection, and
- WHEREAS, The City Council feels that a danger exists

THEREFORE BE IT PROCLAIMED: That I, D. Lynn Crook Mayor of Santaquin, by the power authorized to me by the Utah Code 10-7-12 and by direction of the City Council restrict outdoor water use as follows:

- The north side of main street shall water on even numbered days between the hours of 6PM and 10AM.
- The south side of main street shall water on odd 2. numbered days between the hours of 6PM and 10AM.
- 3. No outside watering will be allowed between the hours of 10AM and 6PM. Anyone found watering between the hours of 10AM and 6PM or a non scheduled day may be subject to a Misdemeanor and the penalties set in section F & H of the Water Ordinance, 86-8, which is incorporated herein by reference.

This Proclamation will not apply to bussinesses that require the water to maintain their Businesses. However the Council asks that voluntary restrictions be applied.

This Proclamation shall take effect at midnight on August 13th, 1992 and will be lifted at midnight on September 20th, 1992 or when the Council approves to lift this Proclamation, which ever comes first.
