

MINUTES OF A REGULAR COUNCIL MEETING
HELD JUNE 19, 1990
AT CITY HALL

The meeting was called to order by Mayor D. Lynn Crook at 7PM.
Councilmembers present: Gerald Fowkes, Keith Broadhead, Dennis Lamb and Marilyn Clayson. Councilman Holman was working. *Clayson offered*
Invocation & Broadhead led the Pledge
Citizens present: Mike Olson and Charla Beeman (reporters).

Approval of the Minutes of June 5, 1990: Councilman Broadhead asked, when permission was granted to allow beer during the rodeo, if this restricted bringing in your own. Council agreed that it did not and Mike Olson said he would make that clear in his newspaper. Councilwoman Clayson then made the motion to approve the Minutes of June 5, 1990. Councilman Broadhead seconded the motion, motion carried.

Forest Service: Mark Sensibough, with the Forest Service, introduced himself to the Council and stated that he had replaced Ray Abriel, who had transferred out of state. He discussed the history of the Trumboldt Bridge Project. He stated that a new "Partnership Agreement" between the City and the Forest Service was available. This Agreement could provide funds to finish the Trumboldt Project. It would be determined on a matching fund basis with labor and services being consider as cash. Mr. Sensibough stated that he would write this Agreement retroactive to the beginning of the Project. He also said that he would work with Councilwoman Clayson for an accounting of Santaquin's contribution for Trumboldt. He thanked Councilwoman Clayson for her cooperative attitude and the many hours she had spent on this Project. Mayor Crook told Mr. Sensibough to negotiate the completion of this project with Councilwoman Clayson as she could give tentative approval to decisions.

Mayor Crook discussed future improvements of roads, stating that the public resented the closing of some roads.

Mr. Sensibough stated that there would be water improvements done at Tinney's Flat, a fee would be charged and they would take NO reservations this year.

Public Hearing on 1990-91 Budget: (Citizens not Present) Mayor Crook reviewed the proposed 1990-91 Budget as attached. Councilman Fowkes made the motion to approve the Budget as presented, Councilwoman Clayson seconded the motion and the voting was unanimous in favor. The landfill rates & monthly billing was discussed, no decision. Mayor Crook stated that he had requested, from the League of Cities, landfill regulations and had not received them.

Business Licenses: Councilwoman Clayson made the motion to approve Kevin Taylor for a Home Occupation License and Janet

Hathaway for a Commercial License. Councilman Lamb seconded the motion, motion carried unanimously.

Bills: Councilwoman Clayson made the motion to approve the bills in the amount of \$17,854.46. Councilman Lamb seconded the motion, motion carried unanimously.

Miscellaneous: Councilwoman Clayson reported that the Library had installed a Book Drop.

Councilwoman Clayson stated that she would be asking approval of new Library Board Members.

Councilwoman Clayson discussed a letter sent from Software Systems, the new Computer Programers. They suggested that the Senior Rate be discontinued. Councilwoman Clayson agreed with this stating that it was unfair and hard to administer. Mayor Crook said that they should address this issue at the Public Hearing on the garbage.

Software Systems also suggested a Maintenance Agreement and a power protection box for the computer system. Council agreed to obtain the Maintenance Agreement through Software Systems Inc.. Councilman Lamb agreed to check on a power box through Word Perfect.

Councilman Lamb reported that he had received complaints regarding Santaquin Police Officers working the Freeway. Mayor Crook said that he would discuss this with Chief Coomes.

Councilwoman Clayson reported on a successful Queen Contest. Mayor Crook and Council agreed that it was a well prepared event.

Councilman Broadhead asked for the City crews' schedule as he needed them for the water project on 500 West and the Robbins water line. Councilman Broadhead also suggested that the part-time worker, Jose Lopez, be retained until some projects are completed. Council agreed.

Councilman Fowkes reported that the mower was broke again and the streets would be mowed as soon as repairs were made.

Mayor Crook reported that Bill Hansen, Attorney, suggested that it be advertised that damaged headstones to be reported to the City.

Mayor Crook reported that Gary Anderson had been legally appointed to finalize the Agreement with Genola.

Mayor Crook reported that a letter would be sent to Nebo School District regarding the replacement of water pipes to the restrooms in the old school. These restrooms will be needed during the Cherry Days Celebration for the Bicycle Event.

Councilman Broadhead reported that both restrooms in the Museum were working.

Adjournment: At 9:15 PM Councilman Lamb made the motion to adjourn, Councilman Broadhead seconded the motion and motion carried unanimously.
