

- 1: Minutes of a regular Santaquin City Council meeting held on Tuesday, June 4, 1985, at City Hall. As Mayor Sandra Peterson was going to be late, Council Chairman Dan Olson presided at the beginning of the meeting. The following Councilmen were also present at the beginning of the meeting: Art Adcock, Clara Goudy and Grant Pay. Mayor Sandra Peterson and Councilman Marilyn Clayson did enter the meeting later. City Recorder/Clerk Sam Sellers recorded the meeting.
- 2: Councilman Olson called the meeting to order at 7:07 p.m. Councilman Adcock offered the invocation and led the pledge of allegiance.
- 3: Prior minutes . The Council reviewed the following minutes: October 2, 1984; October 16, 1984; November 6, 1984; February 19, 1985; May 7, 1985; and, May 21, 1985. Councilman Adcock moved that the minutes be approved as corrected and Councilman Goudy seconded. The motion passed unanimously.
- 4: Council business:
- 5: 1. Current business licenses - The following licenses were reviewed by the Council: (Councilman Clayson entered the meeting at this point.)

- 7: The Council discussed the problem with businesses operating prior to receiving their business licenses, ie., Snyder Bros. and Walt's Bar having a dance. They explained to Mr. Sellers that they should not be operating prior to the license being approved by the Council, as this is what the ordinance stipulates. Councilman Pay moved that the licenses be approved and Councilman Adcock seconded. The motion passed unanimously.
- 8: 2. Chlorine seminar - Mr. Sellers explained that there will be a chlorine handling and safety seminar which Dennis Barnes would like to attend. The cost would be about \$62.00 plus mileage. Councilman Olson moved that Mr. Barnes be allowed to go and Councilman Clayson seconded. The motion passed unanimously.
- 9: 3. Road near Gil Cook's home - Mr. Sellers outlined the problem they are having on this road. He stated that the road washes out primarily because the water user of the ditch does not keep it cleaned out and it overflows near the road. Mr. Sellers said that he felt the person using the water is responsible for any damages while using the water and he or they should be charged with correcting the problem. Councilman Olson said that he felt the city crew should put a pipe across the road and take care of ~~this problem~~. *the road washing out.*
- * 10: 4. Spainhower home - Mr. Sellers explained that this home, which the city owns and rents, is now empty. Councilmen Olson and Goudy stated that they would inspect the home.
- 11: 5. Police report - Chief Knox presented the police report to date to the Council, which report ran from January 1, 1985, through this date. He said that the bake sale at the drug enforcement meeting netted about \$38.00, which will go towards drug enforcement. He stated that the Utah Association of Women (UAW) sponsored the meeting and paid for the fliers, printing and distribution,

which advertised the meeting. The Chief stated that the UAW would not be able to do this for the next meeting, but that he had consented to pay for them out of the \$38.00 received from the bake sale. He said that the total cost of the fliers came to \$35.60. He requested that the Council instruct the City Recorder to cut a check the next day for this amount to pay for the fliers, payable to the UAW. He said that they would then exchange checks, he would give the lady in charge of the UAW the check for the \$35.60 and she would give him the check for \$38.00.

- 12: Councilman Goudy expressed to the Chief that the night selected for the drug task force meetings was one of the busy ones. She also asked if the Chief could use his PA system to announce the meetings in the neighborhoods.
- 13: The Chief stated that, during the period, the PD has written 135 traffic citations, taken 95 complaint reports (does not have, at the moment, a possibility of court action), 54 incident reports (would have court action). Of the 54 incident reports, there were 4 burglaries (3 of which have been solved), 4 assaults, 7 DUI's (with 7 guilty pleas), 4 charges of gambling (3 of which were filed on and received guilty pleas), 3 cases of littering at the city's landfill (1 pleaded guilty and 2 are pending), 8 traffic accidents, 10 thefts (4 of which have been cleared) and 1 custodial interference case, which has been cleared. There were also 13 other incident cases which ranged from public intoxication, obscene phone calls, disturbing the peace and family fights.
- 14: Chief Knox said that the Public Service Dog (PSD) has given 6 demonstrations for the Santaquin PD, 6 building searches for the Santaquin PD, 3 building searches for Payson PD, handled 2 bar fights in Santaquin, 1 suspect control for Santaquin PD, 2 suspect control for Payson PD, 2 suspect trackings for Payson PD, 1 suspect tracking for Salem PD, 2 narcotics searches for Payson PD, 1 narcotics search for Springville PD, 1 body search for Genola PD, 3 suspect search for Utah County SO, 3 lost children for Payson PD, 4 lost children for Santaquin PD, 2 article searches for Santaquin PD and 1 article search for Payson PD.
- 15: Councilman Goudy asked what percentage of success the dog has had in these cases. The Chief indicated that, when there has been something to find, he has found it. He said that, when he was called out on the children searches, the children showed up at home before he could get going. He said that the statistics are call-outs on the dog.
- 16: Councilman Clayson asked if the public service was still required on DUI's and Chief Knox said that it was. Councilman Clayson explained that she could use some assistance. Chief Knox said that he usually has the people contact the City Hall because the Police Department does not keep track of this type stuff. Councilman Clayson asked who does keep track of this. Mr. Sellers said that he does not either. Chief Knox said that the Judge explains to the people that they have XXXX to work off and to contact City Hall. He said that he doesn't normally know what is available in which areas but that he sends them to City Hall and Mr. Sellers is supposed to send them to the Supervisors. Mr. Sellers said that there are some people they would prefer not to have working in the city.
- 17: Mayor Peterson entered the meeting at this point.
- 18: Mr. Sellers reminded the Council that Chief Knox had requested a check for

\$35.60 and wondered if this were going to be acted upon at this time. Chief Knox reiterated that the task force had earned \$38.00 from the bake sale at the last meeting. He said that, in order for the UAW to keep track of their finances, the need to "make the check out to us for that amount." He said that he told them to make that check out to the Task Force on Drug Abuse. Mr. Sellers asked if this check would be receipted by the city and Chief Knox said that it would not. Mr. Sellers asked how the Task Force would be paying for the fliers if the city paid for them and then the Task Force got the \$38.00. Councilman Goudy said that the \$38.00 check would have to be made out to the city if the city paid for the fliers. Councilman Goudy asked why the Task Force could not take that amount and pay for the fliers. Chief Knox said that he would work this out with the Task Force and cut a personal check is he had to to pay for the fliers and then would be reimbursed by the Task Force.

- 19: Jim Stanton - Update of energy saving devices installed. Mr. Stanton explained that the city has received some substantial savings from the devices installed. He said that the devices were installed in the City Hall and the City Shop. After explaining to the Council the savings they have received, they expressed satisfaction. Mr. Stanton asked if the city would issue him a letter with this expressed. The Council asked Mr. Sellers to prepare the letter.
- 20: Open Hearing on Water Ordinance update and resolution. Councilman Goudy expressed her desire to change the 2 shares required for new water connections to one share. Mayor Peterson said that she felt these things would need to be worked out in another meeting. There was not any public input or questions on the ordinance. Councilman Olson moved that Ordinance No. 85-1 be accepted by the City Council and Councilman Goudy seconded. The motion passed unanimously.
- 21: Councilman Olson moved that Resolution No. 85-5 be accepted by the City Council and Councilman Goudy seconded. The motion passed unanimously.
- 22: Open Hearing on Private Materials Ordinance update. Chief Knox expressed concern that the city would have to enforce this ordinance across the board. He said that they could not successfully force one person to move their material and allow someone else to keep theirs. He suggested looking at the possibility of allowing a yearly lease in order to lease some city property for private material storage.
- 23: Mayor Peterson stated that she felt the city ought to prioritize the things which they want to take care of first, with the worst things being at the top of the list.
- 24: Chief Knox said that he has a three page list of violations from Main Street north, which he would begin working on.
- 25: Councilman Clayson moved that Ordinance No. 85-2 be approved by the City Council and Councilman Goudy seconded. The motion passed unanimously.
- 26: Non-agenda item. Chief of Police as Assistant Zoning Administrator. Councilman Goudy moved that the Council appoint Chief Knox and the Police Officers as Assistant Zoning Administrators with the power to handle violations of the zoning codes of the city. *Don 2nd Unanimous.*
- 27: Bart Olson - Establishing trailer on same hook-up as the greenhouses at approximately 455 West 500 South. Mr. Sellers was asked if he had contacted

Mr. Olson about the meeting. Mr. Sellers said that Mr. Olson had contacted him about getting on the agenda, so assumed he would be in attendance. Since Mr. Olson was not in attendance and due to the serious nature of this problem, the Council discussed it anyway.

- 28: The Council instructed Mr. Sellers to write to Mr. Olson and let him know that the trailer should have a separate connection. They also wanted him to include the fact that the city would keep its part of the agreement and that the water would be shut off on the 15 of June, as per the agreement.
- 29: Doni Bufton - Proposal for cleaning old school. Ms. Bufton was not in attendance. Councilman Clayson explained that Ms. Bufton would like to get a group together to clean the school in exchange for the use of the auditorium for one year free for an aerobics class. The Council felt this would be a good exchange.
- 30: Chief Knox explained that a lot of the people going into the school seem to be entering through the band room. He said that he would like to bolt this door shut.
- 31: Councilman Adcock - Councilman Adcock explained that he had received a letter from the Board of Health explaining that the city needs to have 6 inches of fill on the garbage each day. He said that this could make this too expensive for the city.
- 32: Councilman Adcock said that he is trying to get a permit to burn the landfill.
- 33: Councilman Goudy - Councilman Goudy expressed concern about the old trailers which have been moving into town. She said that the City Council ought to look into putting a referendum on the ballot concerning this situation.
- 34: Councilman Clayson - Councilman Clayson stated that she would like to get a permit to burn some limbs, etc., by Lynn Crooks home. Councilman Olson expressed concern with some power lines in the area.
- 35: Councilman Olson - Councilman Olson said that he thought another letter ought to be written to the National Guard requesting an exercise to put the sewer pipe in the creek bottom.
- 36: Councilman Olson stated that the Moto Trials Meet will be held in Santaquin in two weeks. He said that they are also looking for a national site to draw 100+ people from over the US. He said that they have used the Santaquin property before and really like it as a meet. The Council felt that Santaquin would definitely benefit from the Trials being held in Santaquin and encouraged Councilman Olson to have it here.
