Minutes of a regular Santaquin City Council meeting held on Tuesday, August 7, 1984 at City Hall. Mayor Sandra Peterson presided at the meeting and the following Councilmen were present: Art Adcock, Clara Goudy, Grant Pay and Dan Olson. City Recorder/Clerk Sam Sellers recorded the meeting.

Mayor Peterson called the meeting to order at 7:00 p.m. Councilman Goudy offered the invocation and led the pledge of allegience.

<u>Prior minutes.</u> The minutes of July 3, 1984 and July 17, 1984, were reviewed. Councilman Pay moved that the minutes be approved as corrected and Councilman Adcock seconded. The motion passed unanimously.

Councilman resignation. Mayor Peterson read a letter of resignation from Councilman Frank Okelberry as follows:

"July 21, 1984

"TO THE MAYOR AND CITY COUNCIL

"During the last few weeks alot has changed in my life to the point where I have to find work elsewhere.

"When I had back surgery the Doctor told me that I could not do the work that I used to do in the Mines, so I,m left to know other choice than to go elsewhere to look for Employment, since the job prospect is very dull here in Utah. I have chose to move the Nevada because I have a job as a PSY. TECH. working with the youth that has Drug and Alcohol Dependency problems.

"It has been a challenge and alot of fun working with you all and I'm sorry I couldn't finish out my term, but I must go where the opportunity is for me and my family.

"Thank you again,

Sincerely, (Signed) Frank Okelberry City Councilman"

Mayor Peterson said that she felt bad to lose Councilman Okelberry as he was very supportive, yet realized that he had to follow the job opportunities. Councilman Adcock moved that this resignation be accepted and Councilman Goudy seconded. The motion passed unanimously.

Council replacement. Mayor Peterson recommended Marilyn Clayson to replace former-Councilman Okelberry. Mayor Peterson pointed out that this term will run until the next election, when another representative will be elected to run until the end of former-Councilman Frank Okelberry's term. Councilman Olson moved that Mrs. Clayson be appointed to fill this term and Councilman Adcock

Spelling and grammar of original letter retained.

seconded.2 The motion passed unanimously.

The meeting recessed for five (5) minutes while Councilman Clayson was sworn in by City Recorder/Clerk Sam Sellers.

Library Read-A-Thon prizes. Mayor Peterson announced the Library Read-A-Thon winners as follows: First, Michael Knox and Christie Gauze; Second, Angie Pay, and Amy Pay. Mayor Peterson presented the winners with their certificates and prizes. The meeting recessed for three (3) minutes while pictures of the Mayor and winners were taken.

Policy on equipment. Councilman Peterson explained the history of this to Councilman Clayson.

Councilman Olson explained that most of the equipment is useless to most of the employees. He stated that he felt the Shop and acetelene equipment should be available to the employees, as long as any costs are taken care of. He said that this should be extended as a privilege.

Mayor Peterson said that she felt that the Council should trust the judgement of the Supervisors and that the equipment should be used after Supervisor approval.

Councilman Pay said that things have disappeared in the past that the employees are now using their own equipment and tools. He explained that he felt as if the employees should have their own tools, as he is required to in his work. He stated that he also felt the Supervisor should know and authorize this.

Councilman Adcock stated that he felt it would be great if the employees could use the Shop. He said that he felt the Office Personnel should have it spelled out what they could use. Councilman Adcock said that he didn't feel the backhoe should be used.

Councilman Goudy said that she would have no objection, as long as the heavy equipment is not used on private property.

Councilman Clayson asked what would happen if the equipment or tool is being used and it breaks.

Councilman Olson said that it would depend on the equipment and the breakage.

Councilman Pay stated that his only two concerns are what the citizenry will say and that there will be some temptations with a 50 gallon barrel of oil and gasoline available. He said that he is concerned with abuses.

Councilman Olson stated that the Supervisor would be in charge and monitoring this and would be held responsible for abuses.

Councilman Adcock said that this should be interjected into the personnel policy manual.

Audra Hendrickson - Possible sell of property to city. Mrs. Hendrickson explained that she would like to know what the city's plans are for this property.

Mayor Peterson explained to the Hendricksons that the city is hard pressed for a tax base and has been looking for solutions to their problems.

Councilman Adcock said that this land adjoins some other land which the city is looking into purchasing. He said that the city is in the process of proposing to the County a regional landfill concept to be placed on this property. He explained that this landfill possibility would supply the city's whole annual budget to them again. He said that he is excited about having the opportunity of assisting the city in solving some of its budget problems.

Mayor Peterson said that the Council is not proposing anything which would be a detrimate to the city. She said that she would like to see Santaquin as a residential community, but its hard for a small town to attract even a small industry.

Councilman Adcock said that the present County site is in Orem and it is filled. He stated that they are looking for another site. He said that some people are concerned with Santaquin being called the County dump site, but has never heard this about Orem.

Mrs. Hendrickson asked how the material would be transported to the site. Mr. Sellers said that it would be by private carrier in specially built trucks.

Mrs. Hendrickson said that she was under the impression that cities could not purchase property not contiguous to their boundary. Councilman Olson said that this pertains to annexation of property and not purchase.

Mayor Peterson explained that the city's intent is to have a clean and sanitary landfill site and not allow blowing waste.

Mr. Sellers explained that the city has to get an option on the property first, then get an EPA study performed before they know whether it is feasible. Mr. Sellers showed Mrs. Hendrickson a map outlining the property the city is interested in.

Councilman Goudy stated that she is against the project because she is concerned about leaching into the soil and water level and this is the direction from which the wind blows.

Mr. Hendrickson asked how many years the city forsees this as a landfil site. Mr. Sellers said that it would serve for about 20 to 25 years.

Mr. Sellers explained that the EPA has allowed other communities to backfill a landfill site many times until it becomes filled with material. He explained that the K-Mart in Spanish Fork was built over their original landfill. He said that this is a planned Industrial Park now. Councilman Olson said that Provo is now placing a golf course over their own old landfill.

Mr. Sellers said that the present County site in Orem has to be moved. He explained that the cities from Spanish Fork to American Fork are interested in this project.

Councilman Olson said that the real benefit to this is that the truck traffic will not go through town.

Mayor Peterson said that the city has been attempting to attract something to the city for additional income, but have been unsuccessful. She said that this sort of thing, which would be natural in this area, would be a boon to the

city.

Councilman Adcock asked Mrs. Hendrickson how she felt about this. Mrs. Hendrickson said that she doesn't like the idea about a landfill site. She said that she was under the impression that this would be used for industrial growth.

Mrs. Hendrickson said that her decision to sell the property would depend on the price she was offered. Councilman Olson said that he is concerned with going to the expense of an appraisal when there is no committment on the seller's part to sell the property.

Mrs. Hendrickson stated that she is not opposed to the idea if the price is right. Mayor Peterson said that she doesn't know what price would be right, but the city wanted to know if she would consider the proposal.

Mr. Hendrickson said that there might be other alternatives which might be profitable to the city with a railroad and freeway accessable. He said that the option the city is looking at might foreclose the other alternatives.

Councilman Olson explained that there is a lot of land between the city limits and this piece of property and it would be years before the city could annex it. He said that for this reason the city could not use it for an Industrial Site. He said that in the mean time the city could be using it for a landfill site, until the opportunity comes up that it could be used as such. He also explained that this will not be seen from the East because it is situated in the swell.

Mayor Peterson said that the city belongs to an Industrial Development Agency, but have been unable to attract Industry. She said that the city has had the old school listed for two years and no one has even been in to look at it. She said that this suggestion has been the best option the city has seen thus far.

Mayor Peterson said that she was hoping that Mrs. Hendrickson would request a certain price on the property, in order to give the city some idea of what they are looking at.

Mr. Sellers explained that the rail road would not be willing to place a spur onto the West side of the rail in this area because the property slopes uphill away from the rail.

Mayor Peterson explained that the city has been looking for Industrial growth for several years, but for one reason or the other are unable to attract some.

Mrs. Hendrickson said that she is unwilling to make an offer to the city at this time, but will wait to hear a proposal from the city.

Utah League of Cities & Towns convention in Salt Lake.

If the Council were going to act on this this evening. Mr. Sellers outlined the costs as follows: Recorder, who goes for the whole week, \$490.00 and everyone else \$230.00. Mr. Sellers added that the city is financially strapped right now for cash and felt they might not have the money to send anyone to the convention.

Mayor Peterson said that she would like to go, but would pay her own way. She said that she feels the convention is worth the attendance.

Councilman Goudy asked if this were budgeted. Mayor Peterson said that it was.

Mayor Peterson said that she would like to send the Recorder and Treasurer to this convention. Mr. Sellers said that he would rather wait at least until the next meeting to see if the FEMA was coming in. He was asked to place this on the next agenda.

COUNCIL BUSINESS:

1. Current licenses- The following licenses was reviewed by the City Council:

Nan Smith (Perkin's Palace dance permit for a dance on August 4, 1984) \$20.00.

Councilman Goudy moved that this license be approved and Councilman Adcock seconded. The motion passed unanimously.

Landfill Attendant. Councilman Adcock moved that the city hire Ned Rushton as the new Landfill Attendant. Mr. Sellers said that Pili Saluone asked him to suggest the city hire Charles Vance as the attendant. Councilman Goudy seconded the motion and it passed unanimously.

2. Summitt Creek note - Mr. Sellers explained that Summitt Creek has let him know that the note they had taken out for flooding is now due. Councilman Olson said that the city surely could not pay it, so they must extend this.

Councilman Adcock. Councilman Adcock stated that he felt the city ought to build a shelter for the city's float so that it would not be out in the weather. The Council felt that the old fire station could be used until it is sold, then one could be built.

Councilman Adcock asked where the city stood on the Waterline project. Mr. Sellers stated that Don Cole engineering was supposed to have given the city's attorney a plat of the street in this section of town so that the attorney could certify the city owns them. He said that this information was supposed to have been given to the attorney 3 to 4 months ago, but has not been done yet.

Councilman Pay also suggested meeting with the people involved with this year's celebration and get ideas for the next year. The Mayor called a work session for August 29, 1984, for this purpose.

Councilman Olson . Councilman Olson said that six slots for volunteer firemen have become open. He moved that Keith Broadhead, Kevin Taylor, Jesse Smith and Curtis Fowden be appointed to fill four of the six slots. Councilman Pay seconded the motion and it passed unanimously.

Councilman Olson stated that he had discussed the Summitt Creek was with them and they will push the wash and place a "No Dumping" sign on it.

Councilman Olson said that he would like to apply for some state money to

reline the flood ditch on the South side of town. Mr. Sellers said that he checked with the State Emergency Management office which stated that they are waiting to see what FEMA will do before they committ funds.

Councilman Olson said that the City Crew has been in contact with him again concerning raises. He said that the last meeting resulted in encouraging Mr. Sellers to do all he could in this area and said that he felt something should be done.

Mayor Peterson asked the Council if it were their impression that the raise given in July was for all the city employees. Councilman Olson said that he thought everyone was going to get this. Mayor Peterson said that she could not remember making any distinction that the raises were for everyone except for two.

Councilman Pay explained that he has mixed feelings about this. He said that when these two employees were made operators, they were given a one dollar per hour raise, retirement and insurance. He said that he felt this was at least a 100% increase over before the change.

Mayor Peterson said that she could see the Council needed to be more specific on these types of things.

Councilman Adcock said that he was under the impression that these two individuals started the year at \$4.50 per hour and now are getting about \$6.50 per hour plus benefits. Mayor Peterson said that the two were getting \$5.50 per hour and were raised to \$6.50 per hour as operators. Councilman Adcock said that he felt that this still a fairly good raise.

Councilman Olson said that he would be willing to make any cuts he could in order to give these men a raise. He said that this is a very minimal raise.

Councilman Goudy said that when these men were given a raise others in the city felt it was unfair that it was only two getting this.

Mr. Sellers said that when Eddie Neff was raised to Supervisor, he was told this was his raise. When the city authorized raises at the beginning of the next fiscal year, he was told he would receive no raise because he had already received it. Mayor Peterson said that she was just discussing the situation with the two employees and was not discussing the incident with Eddie Neff.

Councilman Goudy pointed out that Mr. Neff got a raise with a clasification and was passed over for a raise when everyone else received one. Mayor Peterson said that Mr. Neff got a raise when he recieved the classification increase. Councilman Olson pointed out that Mr. Neff was also placed on six months probation in the new position as well.

Mr. Sellers asked if the two employees who had been classified as operators were placed on probation for this new position. Mayor Peterson and Councilman Olson said that they had not. Mayor Peterson stated that she didn't know Mr. Neff was placed on probation.

Councilman Olson said that perhaps these two employees ought to be placed on probation as well.

Congressman Dan Marriott. Congressman Marriott explained that he is in the

area politicking because he is running for Governor. He said that he would like to explain his positions to the city.

Congressman Marriott said that his campaign is based upon two things. The most important of which is building the economic base of Utah. He said that he is not a tax raiser and that his record in Congress bears this out. He said that this State has been raising taxes to fund education and other things. He pointed out that if the State wants to keep the taxes low, then they must substantially increase the economic basis. He stated that he and his people plan to write an economic plan in conjunction with local governments, so the local governments have a say in the planning. He said that this plan will hopefully accomplish three things: (1) bring new business into Utah; (2) finding new markets for Utah products; and (3) substantially increase tourism.

Congressman Marriott said that he plans to set up a small business resource center to help local businesses learn how to get federal contracts. He said that there are a lot of federal contracts available and since the State of Utah is 64% owned by the Federal Government, the State ought to be getting a larger piece of the "federal pie".

Congressman Marriott said that he plans to establish some rural enterprise zones, which may be a help to Santaquin. He said that this would provide a special tax incentive for businesses to locate in these zones.

Congressman Marriott said that their objectives are to agressively write an economic development plan for the State, ask for \$10 million to help promote the plan, develop a task force with a member of each community, delegated by the Mayor and Council, involved with it and then agressively begin to find waysof attracting businesses into the State.

Congressman Marriott said that he does not believe in big State government any more than he does in big Federal Government. He said that he felt the State ought to be more of a financial partner with the local governments. He said that each department of State government ought to be evaluated, prioritized and modernized to determine if the functions could be performed at the local level to avoid duplication.

Congressman Marriott said that he plans to develop four task forces: economic development, tax reform, educational reform and streamlining State government. He said that they want to have broad representation from all areas of the State for these task forces.

Congressman Marriott stated that the State needs prison reform very badly. He said that he doesn't think the answer in Regional Prison sites. He said that the prisoners who are in prisons for committing crimes against people should be incarcerated for their crime and punished and that the prison should be a penal institution. He felt that those who committ crimes against property, however, should be expected to pay restitution for their crimes, as well as to pay the State for housing them.

Councilman Adcock asked Congressman Marriott to address three points: (1) what he felt about Geneva, (2) capital punishment and (3) the possibility of changing the meeting schedule of the State Legislature. Congressman Marriott stated that he favors capital punishment for heineous crimes and kidnapping. He said that most of the kids kidnapped wind up dead and the people should put some discouragement in the minds of kidnappers.

Congressman Marriott said that the Geneva problem is a world steel problem caused by steel being dumped on the world market. He said that the USA needs a holiday from foreign dumping and the plants need to modernize. He said that he is the chief sponsor of the anti-dumping law which is now going to pass Congress. He explained that the same problem exists with the copper industry.

Congressman Marriott said that the State of Utah must come up with good alternative jobs because he doesn't think the steel and copper industries are going to have the jobs they have had in the past because the competition is too great.

Congressman Marriott said that the State Legislatures are going to two 45 day sessions and thought that this might alleviate their eleventh hour bills. He said that he would like to give a gold medal to each Legislature which did not pass a bill. He said that the Legislature also spends too much time on issues which are least important.

Councilman Olson mentioned that he is frustrated with the current Governor. He said that the city has had many problems with flooding. He said that he has tried to get in touch with the Governor to ask for assistance, as the city's losses are huge, and the Governor's secretary tells hime to write a letter and then maybe the Governor would call him. He asked Congressman Marriott what he would do to change this.

Congressman Marriott stated that he has held more town meetings and been more places in his district than anyone in history. He said that this would continue as Governor. He also said that he would maintain an open office, forums, be out to the areas and better understand the local issues and problems.

Congressman Marriott stated that he feels the State should be responsible for waters which flood out of its banks. He said that Councilman Olson should really lobby the State. Councilman Olson asked how he could do this when he can't get hold of them and they may not even read a letter which he sends to them. Congressman Marriott stated that if the present Governor spent less time fooling a round in Washington and more time attending to the problems in Utah, the local people would have a lot more going for them. He said that he knows Washington and will not have to spend so much time getting to the source of what he needs and will be able to stay in Utah more.

Congressman Marriott said that the future for Utah is doubling of the population along the Wasatch front and 20 years of drought. He said that the city should have a solid water policy and the responsibility for flooding should be clarified. He stated that Santaqui has it tough because they cannot attract the industry and their tax base is small, yet their cost ratio of damage is greater than Salt Lake. Another problem is Salt Lake gets all the publicity.

Mayor Peterson explained that she was in a Council of Governments meeting and asked if they were aware of the city's project of dredging its catch basin. She said that the person in charge stated that he knew about it and went right on with the meeting, without the Mayor giving them the chance to explain the monetary immensity of the project.

Congressman Marriott asked the Council to look at his record on town meetings. He said that this would continue. He also explained that he is not backed by

power groups. He promised that his office would be open and that he would attend meetings in Santaquin as Governor.

Councilman Goudy asked if Santaquin would have just as much a chance as any other town or city for industry. Congressman Marriott said that they definately would. He also said that he has been looking for the Payson-Dixon line he has heard about. Councilman Goudy said that whenever the County talks about transit or anything, its from Payson North.

Mayor Peterson mentioned that the city has a beautiful canyon with no road up it and asked Congressman Marriott to look into this. They explained that Congressman Nielson and the two Senators already know about this. Mayor Peterson said that there was money allocated for this road to be repaired, but the Forest Service does not want to complete this. Councilman Olson said that there is about 1/2 to 3/4 of a mile washed out in six miles.

Councilman Goudy. Councilman Goudy moved that the books sold during the book sale be declared as surplus property. Councilman Adcock seconded the motion and it passed unanimously. Councilman Goudy explained that they made \$117.00 on the sale, but then had some expenses for handbills and prizes. She said that the Librarian would like to have a shelf for books which can be sold. Mayor Peterson asked Councilman Goudy to see what the other cities are doing along these lines.

Councilman Goudy said that she would like to have seven people on the Library Board. She recommended Eldon McMurray as a member of the board and moved that this be ratified by the Council. Councilman Olson seconded the motion. Councilmen Goudy, Olson and Pay voted in favor of the motion and Councilmen Adcock and Clayson abstained because they did not know the individual.

Councilman Goudy asked if the Councilmen had had an opportunity to read the Business License Ordinance recommendation in depth. They were encouraged to have this ready for the next meeting.

Councilman Goudy asked if the city had hired an Animal Control Officer. She said that she has heard that this is the case, but was not sure as she had not heard anything official. Mayor Peterson said that she thought they were still looking. Mr. Sellers said that no one has asked to be placed on the payroll as such.

Councilman Olson . Councilman Olson asked what the Council is going to do concerning the raises for the two crew members discussed earlier in the meeting.

Councilman Olson explained that he would be in favor of a probation period if this was the concensus of the Council. Mayor Peterson said that this should be from the time they were made operators.

Mr. Sellers said that the 4% raise in January was included in their salaries if the Council determines to make this available to the employees.

Mr. Sellers stated that he brought up each individual employee during the budgeting process. He stated that Mrs. Rosenlund's projected raise had been cut, but that every other raise was approved. He said that he specifically asked about Charles Vance, Mike Cruz, Wade Eva, Jeff Peterson and the Landfill Attendant and was told that, for various reasons, these individuals would not receive a raise at that time. Mayor Peterson said that this apparently went by

her at that time.

Councilman Olson said that in May, when Wade Eva and Jeff Peterson were raised to the operators status, he stated that this would not effect their raise for the new fiscal year.

Mayor Peterson asked if the city were being subsidized for employing Charles Vance and Mike Cruz. Mr. Sellers said the city was not.

Councilman Pay said that he is willing to go into his budget and make some adjustments for these two individuals, ie., Wade Eva and Jeff Peterson.

Councilman Olson said that this should be the same across the board raise. Mayor Peterson stated that this should not necessarily be so because another individual received a raise less than \$1.00 per hour. Councilman Pay said that he would be willing to compromise at \$.50 per hour.

Mr. Sellers stated that the budget would need to be reopened to place this amount of money into the budgetary areas. Councilman Goudy asked how long Mr. Neff's probation was and Councilman Pay said it was six months. Councilman Adcock stated that the probationary period for these two would be up in November, when it should be reviewed.

Councilman Olson said that he would like to see a proposal for the next meeting on what the Council will do and when it will be done.

Councilman Olson said that the Forest Service will be going into the canyon on the 17th of August for their engineer study and survey. He said that anyone who wants to go is encouraged to do so. He stated that they are going to leave Spanish Fork at 9:00 a.m.

- 3. <u>Janitor quit</u> Mr. Sellers was asked to post a bid for this position, with the money to be used to pay their water bill.
- 4. <u>Council</u> <u>title</u> Mr. Sellers asked Councilmen Goudy and Clayson if they minded being referred to as Councilmen. They stated they did not mind.
- 5. Weekly pay periods Mr. Sellers said that the crew has asked if they could be paid each week, rather than every two weeks. He said that this would require about two more hours per week which he does not have and felt the present situation was satisfactory.

<u>Mayor Peterson</u>. Mayor Peterson stated that there was a situation where a person was shooting an arrow towards the road for target practice. She asked if there were any regulations concerning this. The Council didn't think there was.
