

Santaquin City Council meeting January 20, 1979.

Mayor Robert E. Steele called the meeting to order. The Recorder was directed to call the roll which showed councilman Jim Peterson, Clement Kester, Dee Clement, Eldon Greenhalgh. Prayer offered by Dee Clement

Minutes read and Jim Peterson makes motion they be approved and 2nd motion by Dee Clement. Motion carried.

Mayor Steele stated that the meeting was a regularly called meeting and that notice of the time, place and agenda of the meeting had been provided the public by posting at the City Hall.

Mr. George Ostler met with council to discuss cable television. Cable television will cost around \$7.50 per month. 3% will come back to city as a franchise. They will be able to deliver channels 2-4-5-7-11-20. Work on cable television will take about 5 months and there will be no cost on this to the city.

Mr. Davis was present to discuss booster television. total app cost to put up booster would cost city app. \$75,802.00. plus around \$20.00 cost to home owners to boost television antennas.

Mayor reported new council assignments will be made and he will try to meet separately with each councilman prior to assignments.

Eldon Greenhalgh was asked to check with the county to clean dump ground.

Several complaints have been issued against the new marshal, Gary Barney.

Eldon Greenhalgh reported the maintenance men are not pushing the snow back far enough off the roads.

payment to, Chad Bowles for old shirts, (originally purchased by City) holster and buckle was discussed. Council was in agreement that the city not reimburse Mr. Bowles for the shirts but just the buckle and holster that this was owned by Mr. Bowles. Councilmen was in agreement that old clothes or items purchased for workers remain property of the city.

Discussion was held on placing a moratorium on building of homes on East side of Freeway until water lines are improved. No motion made.

Discussion was held on raising of the impact fee, and changes made in impact fee ordinance. Public hearing will be held Feb. 14, 1979 at 9:30 P.M.

Public Hearing was also set for proper procedure on the return to Robert Hales of property the city now owns to Mr. Hales. Deed was signed Dec. 28 and the public hearing should have been held before Mayor signed this legal document for the city. Hearing will be set 10 P.M. Feb. 14, 1979.

Jim Peterson makes motion to issue Mr. Clyde Brown for a plumbing license. 2nd motion Clement Kester. Motion carried.

Idonna W. Crook, Recorder was authorized to attend city recorders meeting to be held

in St. George. February 15, 16, 17.

Zoning and Planning commission term of office was discussed and Mayor reported that  
Jensen had recommended that Lynn Crook be appointed to fill the unexpired term of  
Luella Kay and also for the new vacancy be filled by Sherman Jones.

Eldon Greenhalgh makes motion that This become effective Feb. 1. and 2nd by Clement Kester.  
Also that changes in Commission take place in Feb. instead of Jan.

Mayor took vote on this action and Eldon Greenhalgh, Dee Clement Kester and Clement Kester  
voted for Lynn Crook and Mr. Jim Peterson voted against.

Clement Kester makes motion loaders be put up for bid to sell. These are old and not in  
use and council felt like other than just stand and used. Council felt like it would cost  
too much for repairs.

Clerk was authorized to order gift certificates for Wayne Ford, Mrs. Whatcott, Mrs. Todd,  
Mr. Anderson for service during the childrens Christmas party.
