**WHEREAS**, vehicles and equipment are replaced on a rotating basis as they become outdated, obsolete, and no longer serve their purpose, and


**WHEREAS**, the storage of vehicles and equipment could become a nuisance,

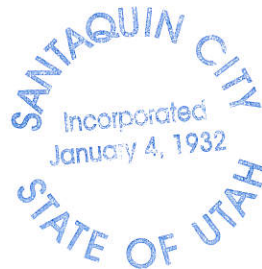
**NOW, THEREFORE, BE IT RESOLVED**, that the following vehicle and equipment be declared surplus property to be sold at public auction.
