We	, the undersigned, understand and agree to the following:
1.	UCMC will audit the utilities/bills indicated above for all of our locations to identify opportunities to reduce costs. All recommendations shall be made in writing and are subject to our approval. When any recommendation is implemented, either by us or UCMC, it shall be considered approved.
2.	If UCMC is unsuccessful in obtaining refunds/credits or cost reductions there shall be no further commitment or fee due to UCMC.
3.	To pay UCMC fifty percent (50%) of all refunds or credit adjustments and the same percentage of each and any continuing savings that occur from approved recommendations each for a period of sixty (60) months from the time savings first appear on utility bills.
4.	To give UCMC access to the above bills and service contracts for the initial audit and throughout the billing period. To sign and renew "Letter of Authorization" allowing UCMC to obtain billing copies and access other required account data directly from utility providers. To send utility billing copies to UCMC upon request and provide online access when available.
5.	Billing from UCMC may be made each month and any savings will be payable during that billing cycle upon the receipt of an invoice setting forth in detail all savings.
6.	If we receive refunds and savings and fail to pay UCMC in a timely manner we understand we may be charged a monthly late fee of 1.5% of any unpaid balance. Payment to be Net 10 late fee after 30 days.
7.	This agreement may continue to renew for consecutive two-year periods if agreed in writing. In the event of default, attorney fees along with court and collection costs may be charged. This agreement is binding on successors or assignees. This agreement is the complete agreement.
