PUBLIC HEARING, DISCUSSION AND POSSIBLE ACTION ITEMS

Williams K Subdivision

Commissioner Peterson opened the public hearing regarding the Williams K Subdivision. Mr. Marker said all lots in the proposed subdivision comply with minimum requirements for R-8 zone. The subdivision has been through the DRC process, and there are some DRC comments that still need to be addressed. The sewer and water lines for lot 2 currently run through the building footprint for Lot 1.

Kathleen Williams addressed the Commission. Ms. Williams said they do not plan to sell Lot 1 at this time, but when the lot is needed, the water and sewer will be connected. Commissioner Adcock noted that it would be cleaner to make sewer and water provisions now. Commissioner Peterson closed the public hearing.

Commissioner Adcock made a motion to approve the Williams K Subdivision, contingent on DRC comments being addressed. Commissioner Wood seconded the motion. The vote to approve the Williams K Subdivision was unanimous.
