Minutes of a Board of Adjustment meeting held Tuesday, September 19, 1979, at 6:00 A. M., 68 East Main Street, Santaquin, Utah.

Present were Fred Openshaw, Glen Jarvis, Lynn Crook, Micheal Christensen, Roxanne Lamb, Wanda Jones, ElRay Davis and Ramona Rosenlund, Secretary.

Meeting was called to order by Mr. Openshaw. As Mr. Jarvis was just called to the Board and this was his first hearing, Mr. Openshaw read the paragraphs of the Ordinance sections involved in the appeal made by Mrs. Lamb and those paragraphs where the powers of the Board are outlined.

Mrs. Lamb explained she wanted to open a gift shop in a front room of her home and sell only items handmade by herself and her partner, Mrs. Jones or other housewives who would bring their items to the home for sale on consignment. None of the items to be for sale would be produced by commercial interprises. She explained there was parking for several vehicles at both the side and front of the premises without interferring with traffic. Also that there was adequate room in the home for storage of any materials used in connection with the shop.

Mr. Crook made a motion that the Board approve the appeal of Mrs. Lamb as he felt it was a good way for young homemakers in the city both to make some money and use their talents. Mr. Christensen seconded the motion and it passed unanimously.

Mr. Davis told the Board he wanted to build a building for a welding shop on his premises and had plans for one 25' x 40' but that if necessary would change the size of the building to conform to the Ordinance.

Mr. Openshaw read the sections of the Ordinance pertaining to Home Industry showing were Mr. Davis would conform if his building was no larger than 900 square feet in area.

Mr. Davis explained he would have a black-topped road from the street to the new building at the back of his lot. It was indicated to the Board on a map where the new building would be located which is out of the way of neighbors.

Mr. Jarvis made a motion that the appeal of Mr. Davis be granted providing he would make his building 900 square feet rather than the planned 1,000 square feet since there is no Industrial Zone within the City limits. Mr. Christensen seconded the metion and it passed unanimously.

Meeting adjourned at 6:35 A.M.
