### PLANNING COMMISSION MINUTES

The following are the minutes of the regular meeting of the Planning Commission of the City of Santaquin, Utah. The meeting was held on Tuesday, November 8, 1994, in the Santaquin City Council Chambers.

The following Board members were in attendance: Brent Vincent, Kurt Stringham, Dick Kay and Shawna Johnson. Brad Greenhalgh was excused. Also present were Councilman Paul Bean and City Planner, Dale Berg.

The meeting was called to order by Brent Vincent.

1. <u>Jack Jarvis, Lavon Ross:</u> annexation

Mr. Jarvis and Mr. Ross have decided not to proceed with their annexation.

2. Preliminary and final approval Peterson Subdivision:

No one present to speak on behalf of Peterson Subdivision.

3. Recommendation of proposed Subdivision Ordinance to the City Council:

Brief discussion on the names of several streets.

## AN ORDINANCE AMENDING THE NUMBER OF MEMBERS OF SANTAQUIN CITY PLANNING COMMISSION

BE IT ORDAINED BY THE CITY COUNCIL OF SANTAQUIN, UTAH, THAT SECTION 1 OF ORDINANCE NO. 90-4 BE AMENDED AS FOLLOWS:

SECTION 1: CREATION OF A PLANNING COMMISSION. There is hereby created a Planning Commission with and for Santaquin City to be known as the Santaquin City Planning Commission. Said Commission shall consist of seven (7) members, all of which are to be appointed by the mayor with the consent of the City Council from among qualified electors of the City. A secretary will also be appointed and may be a member of the Commission. Members shall be selected without respect to political affiliations and shall serve will be compensation except for reasonable expenses. The secretary will be compensated for time spent in connection with the Commission unless the secretary is a member in which case member would require. One member of the City Council shall serve as an ex officio member of the Planning Commission but shall have no vote. A Building Inspector shall also be appointed and compensated according to agreement with City Council.
