#### **-Discussion and possible action of the Chair and Vice Chair positions:**

#### **-Discussion and possible action on our park signs looking uniform:**

Assistant City Manager Dennis Marker stated that when they added the Pole Canyon Park Fishing

pond, Santaquin City promised the family that donated the land, they would name the park after the family. Theodor Allen Park. Assistant City Manager Marker stated that they are updating the plans and they need to determine the names of all of the parks and make signs so that they are all uniform. The board talked of different signs that would look good here in Santaquin. No decisions were made, Assistant City Manager Marker thanked the board for all of their input and ideas.

**-Discussion and update on the Blu Line Survey results and Master Plan:**

Assistant City Manager Marker stated that this was over the next 10 years which parks could get developed. He mentioned putting a possible park on the north end of Santaquin next to the waste water treatment plant. A possible gateway on main and 400 east. A possible rodeo grounds. Possible construction of the cemetery. We have to keep a 10 year plan here in Santaquin.
